



## 100-MILE RIDE FOR MISSING CHILDREN – 2018 WAIVER AND COMPLETE RELEASE OF LIABILITY

**This is an important legal document, please read carefully before signing below.**

As consideration for my participation in the Ride for Missing Children-2018 (the “Ride”), I certify that I am: (1) physically fit and have not been advised otherwise by a qualified medical person; (2) have sufficiently trained to participate in the “Ride; and (3) am over the age of eighteen (18) years old. I acknowledge the Ride carries with it the potential for serious injury, property loss and death arising from, but not limited to, the following: terrain, road conditions, weather, condition of equipment, vehicular traffic, and actions of participants, volunteers, spectators, and/or producers of the Ride.

**On behalf of myself and my executors, administrators, heirs, next of kin, successors and assigns, I take the following actions:**

1. Release and discharge The National Center for Missing and Exploited Children (“NCMEC”), sponsors of this event, event directors, volunteers, law enforcement, all cities and municipalities in which the event is conducted, and all affiliated organizations, individuals and entities (and all their respective officers, directors, agents, employees and members) (“Parties”) from any and all liability, and waive my rights with respect to any and all claims for damages arising from death, personal injury or property damage, including but not limited to, medical bills, lost wages, pain and suffering, attorney’s fees, court costs and damage to my bicycles(s) and related equipment, which I may have, or may accrue as a result of my participation in the Ride;
2. Indemnify and hold harmless the Parties for any injuries, claims or demands for reimbursement of any contributions, payments of expenses arising from the Ride, the postponement or cancellation of the Ride, and any related Ride Activities in which I may be involved, including all liability, claims, actions, demands, expenses, attorney fees, breach of contract actions, breach of statutory duty or other duty of care, warranty, strict liability actions and all other causes of action whatsoever arising out of or connected with my participation in the Ride.

3. Consent, without expectation of review or payment, to the use of my name, photograph, voice or likeness by the Parties and/or their licensees in connection with any NCMEC-related activities, including but not limited to educational, promotional, fundraising, publicity, prevention and awareness at NCMEC's sole discretion.
4. Consent to receiving medical treatment as may be deemed advisable in the event of injury, accident and/or illness during the Ride.
5. Consent to organizers of the Ride and their agents or representatives transporting my bicycle(s) and other equipment.

I understand that if any provision of this Waiver and Complete Release of Liability is deemed to be invalid, illegal or unenforceable under any applicable statute or rule of law, it is to that extent to be deemed omitted, and the remainder of this Waiver and Complete Release of Liability shall be valid and enforceable to the maximum extent possible.
