DEPOSIT INFORMATION WEDDINGS: A NON-REFUNDABLE DEPOSIT OF \$950 WITH A COMPLETED SIGNED PRIVATE EVENT AGREEMENT IS REQUIRED to confirm your reservation / hold your event date. ANY CANCELLATION of your function will result in a forfeit of your entire deposit.

DEPOSIT INFORMATION PRIVATE EVENTS: A NON-REFUNDABLE DEPOSIT OF \$500 WITH A COMPLETED SIGNED PRIVATE EVENT AGREEMENT IS REQUIRED to confirm your reservation / hold your event date. ANY CANCELLATION of your function will result in a forfeit of your entire deposit.

GUEST COUNT The guaranteed count must be provided to Event Coordinator no later than 10 days prior to the event date. Your guest count may only be increased past this date. Should your guest count decrease, you will be charged and responsible for payment for the guaranteed count represented on this contract. GUEST COUNTS RECEIVED AFTER 10 DAYS PRIOR MAY CAUSE ADJUSTMENTS TO CONTRACT as per The Winery at St. George's discretion — details on this contract including MENU will become null and void and adjusted as necessary as to accommodate late guest count.

20% Service Charge and 7.375% Tax will be added to ALL Private Events. **Tax Exempt status will be accepted for Fundraisers only.** ANY PRICE ADJUSTMENTS at The Winery at St. George's discretion only and noted on this contract.

FINAL PAYMENTS on Event Balance: 50% OF APPROXIMATE PAYMENT DUE IS DUE FIVE (5) MONTHS PRIOR TO EVENT DATE AND NON-REFUNDABLE AFTER THIS DATE. FINAL PAYMENT / PAYMENT BALANCE IS DUE IN FULL 48 HOURS IN ADVANCE OF EVENT. Final Payments must be paid by Cash, Credit Card, Certified Check or Money Order. NO PERSONAL CHECKS ACCEPTED FOR FINAL PAYMENT. Final Payment dates are noted on this contract. Special Payment arrangements can be made in advance and will be subject to The Winery at St. George's discretion and noted on this contract. The Winery at St. George gift cards are not accepted as payment for any function / event.

NO BALLOONS, CONFETTI OR SPARKLES are permitted for decorating Winery. CANDLE USAGE must be approved prior to event. Weddings: Flower Girl petal tossing must be approved prior to event.

No outside Wine, Food, Liquor, Desserts of any kind, or Champagne are permitted at The Winery without prior permission.

The Winery at St. George requires GIFT TABLES / GIFT AREAS be set up on our Altar / Stage Area or within site of responsible event guest. Any deviation from such requires written consent from the Host(s). Winery Staff does not assist in transferring times / gifts / personal belongings / food / flowers / into or out of the Winery building. Please plan accordingly.

Brides & Grooms / Event Hosts: please assure Cake Designers / Bakeries deliver and set up initial Wedding Cake / Desserts on assigned table or stands. Any cake "to-go" boxes to be provided by bakery. The Winery at St. George and staff are not responsible for any cake / dessert / cake topper / cake decorations / cake flowers / dessert platters / bakery displays / cookie trays left at The Winery after event and up to 24 hours after event end time noted on this contract. Special arrangements need prior permission and at The Winery at St. George's discretion.

The Winery at St. George is not responsible for any coats / jackets / purses / guest personal belongings hung in / at our Winery Entrance Coat Rack or Bell Tower. These areas are for customer use only and is not monitored by Winery Staff.

Doors remain open during Event UNLESS OTHERWISE REQUESTED BY EVENT HOST IN WRITING.

LOUNGE RESERVATIONS ONLY: *Please note your party is not "private". Please respect other patrons by keeping noise events to a minimum. Therefore, please refrain from making speeches, clapping, or anything that may disrupt the restaurant. All FINAL BILLS / TABS will be presented on ONE BILL. NO MORE THAN TWO (2) CREDIT CARDS WILL BE ACCEPTED FOR FINAL PAYMENT. Thank you!*
