Please Note: "You or Student" below represents either the student or responsible party.

- 1. TUITION/BILLING: Your account will be billed a prepaid MONTHLY TUITION on the 1st of each month through JULY 31, 2017. PAYMENT is DUE on the 1st of each month. ... 2. CHANGING or DROPPING CLASSES: You may NOT drop classes to take effect in the current month you are in. ... 3. CREDIT CARD REQUIREMENTS: We request a credit card number to be on file for each student. ... 4. AUTOPAY: If you choose to register for Autopay, you must mark the authorization box on your registration form or fill out a "Credit Card Authorization Form" at reception. ... 5. DELINQUENT TUITION/FEES: Tuition that is not paid by the 10th of each month WILL incur a \$15 late fee. ... 6. RELEASE: By signing this contract you agree to release and forever discharge, Center Stage and their employees from any liabilities growing out of or related to any activities in which I or my child may participate in. ... 7. STUDIO RENTAL: Students may rent a studio at Center Stage for practice or private lessons. ... 8. PAYMENTS/NFS Fee: We accept Checks, Cash, Debit and Major Credit Cards. ... 9. PARENT RESPONSIBILITY: PLEASE pick up your child after their class or classes have been completed. ... 10. CLASS OBSERVATION: Due to student distraction, we request that parents do not enter into the studio while class is in session. ... 11. CLASS ATTENDANCE: If you attend a class that you are not registered for, you will be charged a full month's tuition for that class. ... 12. RECITAL/COSTUME FEE: SUMMER TERM HAS NO RECITAL OR COSTUME FEE DUE. ... 13. WAIVER/RELEASE In addition, some classes and events may be photographed and recorded by television, video, photography, or other methods. ... 14. ENFORCEMENT: If any legal action arises from the provisions of this agreement, the prevailing party is entitled to recover its attorney's fees and costs.
