



Notice of Race

SM 2018 [Swedish DN Ice Yacht Championship 2018]

March 17-18th 2018

1. Rules

- 1.1 Races and scoring will be managed according to IDNIYRA By-Laws, NIA racing rules, the Swedish DN Regulations, the Sailing Instructions and the Skippers Meeting.

2. Eligibility

- 2.1 All competitors shall be members of their national DN class association. All DN ice yachts shall meet the requirements of the Official Class Specifications.
- 2.2 Each competitor shall be insured with valid third-party liability insurance with a minimum cover of €500.000, or equivalent value in other currency.
- 2.3 Competitors participate in the regatta entirely at their own risk. The organizing authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.
- 2.4 Swedish competitors shall have national racing license for ice sailing.

3. Notices to Competitors

- 3.1 Prior to event official notices will be posted in the event page at the DN Sweden website www.dnsweden.se.
- 3.2 During the event notices will be posted on a notice board in the starting area.

4. Entry

- 4.1 Entry shall be made via online entry form on the event page at www.dnsweden.se.
- 4.2 Entry fees, to be paid in connection with registration in the launching area (cash or Swish)

Senior (born 1994 or earlier)	SEK 400
Junior (born 1995 or later)	SEK 200

5. Registration

- 5.1 Registrations shall be made on site in the launching area no later than times announced in schedule of events.
- 5.2 Competitors shall be able to display a valid third-party liability insurance certificate covering at least €500.000 in Swedish or English.

- 5.3 To be allowed regatta registration every sailor must pass a "Rule Test". It consists of questions regarding the right of way rules. If someone fails the test, he or she will get another attempt. If failed again the sailor must undergo an aural hearing with the Protest Committee. The Protest Committee will decide whether the sailor understood the rules or not. If the sailor fails, he or she is not allowed to register and cannot participate in the regatta.

6. Schedule of Events

- 6.1 Final venue selection: no later than Thursday March 15th 20:00 (CET).

- 6.3 11 races are scheduled (qualification series excluded).

- 6.4 3 races are required to constitute a regatta.

- 6.5 The organizing authority are if deemed appropriate able to postpone the regatta to the backup weekend March 24-25th or to a weekend at the end of 2018.

7. Scoring

- 7.1 The scoring system of the IDNIYRA By-Laws will apply, modified to comply with the Swedish DN Regulations (NoR 7.2).

- 7.2 Discards: if 4 races are completed, the points for each yacht's poorest race will be eliminated from the scoring with the exception of DNE. In that case the next-worse race shall be eliminated. If 8 races are completed, the points for each yacht's two poorest races will be eliminated from the scoring with the exception of DNE. In that case the next-worse race shall be eliminated.

8. Prizes

- 8.1 Prizes will be awarded to the overall top 3 sailors, top 3 Swedish sailors, top 3 Swedish junior sailors, best club team and best foreign sailor.
