## **JURY TRIALS:**



### ***Commonwealth of Kentucky v. Alan Vandiver***

On November 2, 2009, Assistant Commonwealth's Attorney, Whitney H. Westerfield, tried the case of Commonwealth v. Alan R. Vandiver. Mr. Vandiver was indicted on charges of Trafficking in Marijuana over 5 lbs and Possession of Drug Paraphernalia. The Kentucky State Police executed a search warrant on a Mannington residence where Mr. Vandiver resided after a suspect in another case informed State Troopers that he had just purchased marijuana from Mr. Vandiver at that location. State Troopers found a large seed-bag filled with several "bricks" of dried marijuana. Bricks of the controlled substance are often made by dealers when dealing in larger quantities. Mr. Vandiver's residence also contained a surveillance camera that was water/weather proof. The bricks of marijuana totalled nearly 22 lbs of marijuana which obviously far outcales the quantity one may have for personal consumption. The jury rendered a guilty verdict against Mr. Vandiver on both charges, and, after hearing of his prior felony conviction (also for trafficking in marijuana) set his sentence at 6 years and a \$500 fine. On January 6, 2010, Vandiver was sentenced to serve the 6 year sentence and was remanded to the custody of the Kentucky Department of Corrections.



### ***Commonwealth of Kentucky v. Michael Wayne Ladd***

On November 5, 2009, Assistant Commonwealth's Attorney, Kathi Adams, tried the case against Michael Wayne Ladd in Division I. Ladd was charged with 1<sup>st</sup> Degree Sexual Abuse of a Victim under 12 Years of Age, a Class C Felony, and Intimidating a Participant in the Legal Process, a Class D Felony. The witnesses for the Commonwealth included investigating Detective Randall Green of the Hopkinsville Police Department, the 11 year-old victim, her 13 year-old cousin, her aunt, and her mother, whom the defendant was dating. The victim took the stand and described in detail how the defendant had digitally penetrated her while her mother was asleep in another room. There was no eye witness to the crime. However, the 13 year-old cousin, who was in the kitchen during the incident, testified that when she heard the victim yelling at Ladd in the other room, she peered into the bedroom and saw Ladd very quickly pull his hand away from under the victim's long T-shirt. Ladd took the stand in his own defense, denying that he was even at the victim's house, and claiming to have been visiting another girlfriend that night. Medical records were also admitted into evidence. The jury found Ladd guilty of both counts, and was then instructed that Ladd was indicted as a Persistent Felony Offender. Because the jury did convict Ladd of the PFO indictment, and he had a prior felony Sexual Abuse conviction wherein the victim was a child under 12 years of age, he was eligible for a Life sentence. Ladd was not only on parole at the time of the offense tried, but he was also on the Sex Offender Registry. Ultimately, the jury recommended that Ladd receive a sentence of Life, Without the Possibility of Parole for 25 Years. His formal sentencing hearing is set for January 27, 2010.



### ***Commonwealth v. DeMarcus McCarley***

On November 6, 2009, Assistant Commonwealth's Attorney, Whitney H. Westerfield, tried the case of Commonwealth v. Demarcus McCarley on two counts of the charge of Trafficking in a Controlled Substance, First-Degree. McCarley was indicted on these charges after having made a transaction of cocaine for money, with an undercover confidential informant, on two separate occasions. The case proceeded in a rare fashion because McCarley entered a plea of guilty to begin the day. He asked that the jury be empaneled to perform the second phase of every jury trial in the Commonwealth - sentencing. The Commonwealth put on proof of the case and played the videos of the transactions for the jury. The jury subsequently imposed a sentence of 6 years on each count of trafficking, and ran the sentences concurrently, or simultaneously, for a total sentence of 6 years. During a sentencing hearing on December 15, 2009, McCarley was sentenced to 6 years and was remanded to the custody of the Kentucky Department of Corrections to serve the balance of his sentence.



### ***Commonwealth v. Leslie Ware***

On November 12, 2009, Commonwealth's Attorney Lynn Pryor tried the case of Commonwealth v. Leslie Ware. Ware, who was represented by Hon. Jack Faust, was charged with 2<sup>nd</sup> degree Assault and Tampering with Physical Evidence after she stabbed Ciera Young Teal on October 16, 2008. According to witness testimony, Teal was having an altercation with her then-boyfriend and threw a rock, which missed him and broke the window to Ware's residence. Ware grabbed a knife, ran after Teal, and stabbed her 8 times - in the arm, back and under her eye. Ware then threw the knife into a nearby garbage can before the police arrived. Teal's injuries were serious and left scars, but were not life-threatening. The jury found Ware guilty of 4<sup>th</sup> degree Assault and Tampering with Physical Evidence, for which they selected a sentence of three years. Ware will be formally sentenced in Judge Self's court on February 10, 2010.

## **GUILTY PLEAS/SENTENCINGS:**

This section of our Newsletter includes a brief description of sentencing hearings that took place during the previous two-month period. While many consider "plea-bargains" as a negative way to resolve cases, defendants typically plead guilty to the same charges they are indicted for. When the defendant is sentenced following a guilty plea, they stand convicted of the charges just as if a jury had found them guilty. Therefore, the only thing they bargain away is their right to a jury trial and right to appeal. You will also see the jail-intake photos of these Defendants, when available.

Once the Commonwealth makes an offer and the Defendant enters a guilty plea, it is up to the Circuit Judge to determine if the Defendant will be probated or sentenced to prison. Another option that the judge has is one that must be agreed upon by the Defendant and by the Commonwealth - Pretrial Diversion.

**Pretrial Diversion:** Kentucky Revised Statutes allow for a person to be placed on a "Pretrial Diversion" under certain circumstances. 1) All charges which they are pleading guilty must be Class D felonies (1-5 years); 2) The person must enter a plea of guilty, or a plea pursuant

to North Carolina v. Alford before becoming eligible for pretrial diversion; 3) Persons ineligible for probation, parole or conditional discharge under KRS 532.045 shall be ineligible; 4) a person convicted of a Class D felony for which early release is disallowed by statute including KRS 189A.010(8) and KRS 189A.120(2) [DUIs] shall be ineligible 5) No person shall be eligible for this program more than once in any five (5) year period. A person who is placed on diversion is considered a convicted felon during the period of their diversion and is subject to the same conditions as someone who is on felony probation. If someone completes that period of diversion/probation without any infractions or new charges, they can move the court to have their case dismissed/diverted, and they are no longer a convicted felon.

**Commonwealth v. Jermaine Jackson**

On November 4, 2009, Jermaine Jackson entered guilty pleas in two different indictments: (1) 10 years in 09-CR-00086 for 2 counts of Trafficking in Cocaine, Subsequent Offense; and (2) 20 years in 09-CR-00114 for charges of Trafficking in Cocaine, Subsequent Offense, While Armed, Trafficking in Marijuana within 1,000 yards of a School, Possession of a Handgun by a Convicted Felon, Third-Degree Assault, Fleeing or Evading Police, Theft of Identity, Tampering with Physical Evidence, Failure to Illuminate License Plate and Improper Signal. Jackson was sentenced to 30 years in prison on November 4.

On April 1, 2009, David Shepherd entered guilty pleas to the charges of Tampering with Physical Evidence, Possession of Xanax, Possession of Marijuana and Second-Degree Criminal Mischief. The Commonwealth recommended a sentence of 2 years; however, Shepherd failed to appear for his final sentencing date. Therefore, the Court went along with the Commonwealth's request to sentence Shepherd to the maximum of 5 years in prison when he was finally sentenced on November 4, 2009.

On June 30, 2009, Venisha Radford pled guilty to 2 counts of Assault, Second-Degree for stabbing Sherika Gee and puncturing her lung. On November 4, 2009, Radford was sentenced to 5 years in prison in

compliance with the Commonwealth's recommendation that she be denied probation.

On June 23, 2009, Sheyama Radford pled guilty to 2 counts of Facilitation to Assault, Second-Degree for assisting her co-defendant, Venisha Radford, in the stabbing of Sherika Gee. On November 4, 2009, Radford was sentenced to 12 months on each charge, which was probated on the condition that she stay away from Sherika Gee.

**Commonwealth v. Kent Davis**

On August 12, 2009, Kent Davis entered guilty pleas to Cultivating Marijuana [more than 5 plants] and Possession of Drug Paraphernalia. Davis was sentenced to 5 years on November 10, 2009, and he was placed on a felony pre-trial diversion for a period of 5 years since this was his first felony.

**Commonwealth v. Montres Finch**

On September 9, 2009, Montres Finch entered guilty pleas to 2 counts of Trafficking in Cocaine. Simpson was sentenced to 7 years in prison on November 10.

On September 24-25, 2009, Jeffrey Hale was tried and found guilty by a jury of First-Degree Unlawful Transaction with a Minor. On November 10, 2009, Hale was sent to prison for a period of 10 years where he will have to complete the Sex Offender Treatment Program. He will also have to register on the Commonwealth's Sex Offender Registry upon his release.

**Commonwealth v. Terron McNeal**

On August 24, 2009, Terron McNeal entered guilty pleas to charges of Trafficking in Cocaine, Trafficking in Marijuana, and Possession of Drug Paraphernalia, Subsequent Offense. On November 10, 2009, McNeal was sentenced to 6 years, but was probated with the condition that he serve 60 days in jail prior to July 30, 2010.

**Commonwealth v. Melody Burrus**

On September 9, 2009, Melody Burrus pled guilty to Possession of Drug Paraphernalia Subsequent Offense, Driving Under the Influence 2<sup>nd</sup> Offense, Possession of Marijuana, and Disregarding a Traffic Device [in Indictment 09-CR-00136], and Assault 4<sup>th</sup> Degree [in Indictment 09-CR-00466]. On November 10, 2009, Burrus was sentenced to 3 years which was probated on the condition that she complete the Drug Court Program.

**Commonwealth v. Eric Poole**

On September 23, 2009, Eric Poole pled guilty to 3 counts of First-Degree Possession of Cocaine, 3 counts of Possession of Drug Paraphernalia, Subsequent Offense, and Tampering with Physical Evidence [in Indictment 09-CR-00450], and Second-Degree Escape [in Indictment 09-CR-00564]. On November 10, 2009, Eric Poole was sentenced to 4 years in 09-CR-00450 and to 1 year in 09-CR-00564. The sentences were probated on strict conditions, including that he abstain from drugs and alcohol.

**Commonwealth v. Joseph Braswell**

On August 12, 2009, Joseph Braswell entered a guilty plea to one count of Fraudulently Obtaining Food Stamp Benefits Over \$100 and one count of Fraudulently Obtaining Medicaid Benefits Over \$100. Braswell was sentenced to 2 years on November 10, 2009. Braswell was granted probation, and he will remain on probation for a period of 5 years or until his restitution is paid in full, whichever is longer.

**Commonwealth v. Copy Stroud**

On August 12<sup>th</sup>, 2009, Copy Stroud pled guilty to Possession of Cocaine and Possession of Drug Paraphernalia, Subsequent Offense.

The Commonwealth recommended a sentence of 3 years, which was imposed during Stroud's sentencing hearing on November 10, 2009. Stroud's sentence was probated for a period of 5 years, and he will continue his self-administered treatment plan.

**Commonwealth v. Michael McClendon**

On August 12<sup>th</sup>, 2009, Michael McClendon pled guilty to Burglary, Third-Degree, 2 Counts; and Knowingly Receiving Stolen Property over \$300, 2 Counts. The Commonwealth recommended a 3 year sentence, which was imposed on November 10, 2009 during McClendon's sentencing hearing. McClendon's sentence was probated and diverted for a period of 3 years.

**Commonwealth v. Sean Fowler**

On August 12<sup>th</sup>, 2009, Sean Fowler entered a plea of guilty to Burglary, Second-Degree, and Giving an Officer a False Name. During his final sentencing hearing on November 10<sup>th</sup>, 2009, Fowler was sentenced to 5 years, and that sentence was probated for a period of 5 years.

**Commonwealth v. Kevin Poston**

On September 23<sup>rd</sup>, 2009, Kevin Poston pled guilty to Possession of Cocaine and Resisting Arrest. The Commonwealth recommended a sentence of 3 years, which was imposed during a sentencing hearing on November 10<sup>th</sup>, 2009. That sentence was probated and diverted for a period of 5 years.

**Commonwealth v. Gregory Whitlock**

On September 9<sup>th</sup>, 2009, Gregory Whitlock pled guilty to Possession of Ecstasy, Tampering with Physical Evidence, and Possession of Marijuana. The Commonwealth recommended a sentence of 3 years, which was imposed during a sentencing hearing on November 18<sup>th</sup>, 2009. During that hearing the sentence was probated and diverted for a period of five years.

On September 9, 2009, Ashton Armstrong entered guilty pleas to First-Degree Wanton Endangerment, Knowingly Receiving a Stolen Firearm, Tampering with Physical Evidence and Operating a Motor Vehicle on a Suspended Operator's License. On November 18, 2009, Armstrong was sentenced to prison for a period of 5 years.

On September 21, 2009, Michael Hayes entered guilty pleas to the charges in two indictments: (1) 12 months for Possession of a Controlled Substance, Third-Degree, Possession of Marijuana, Possession of Drug Paraphernalia and Trafficking in a Legend Drug; and (2) 5 years for Facilitation to Manufacture Methamphetamine and Possession of Drug Paraphernalia. Hayes was sentenced on November 18, 2009 to 5 years and was placed on felony pre-trial diversion for 5 years as this was his first felony conviction.

years, and she was placed on a felony pre-trial diversion for a period of 4 years on November 18, 2009.

On August 12, 2009, DeAnthony Babb entered guilty pleas to the charges of Trafficking in Marijuana within 1,000 yards of a School, Cultivating Marijuana [less than 5 plants], Possession of a Defaced Firearm, and Possession of Marijuana and Drug Paraphernalia, both while armed.. He was sentenced to 8 years on November 18, 2009, and he was placed on a felony pre-trial diversion for a period of 5 years since he had no prior felony convictions

Shelby-Bapp was sentenced on November 18, 2009 to 3 years. Shelby-Bapp was granted a pretrial diversion, and will remain on probation for a period of 5 years or until her restitution is paid in full, whichever is longer.

On August 26, 2009 Alandria Stokes entered a guilty plea to one count of Fraudulently Obtaining Food Stamp Benefits Over \$100. Stokes was sentenced to 3 years on November 23, 2009. Stokes was granted a pretrial diversion, and she will remain on probation for 5 years or until her restitution is paid in full, whichever is longer.

On August 12<sup>th</sup>, 2009, Tarcous Haskins pled guilty to Possession of a Drug Paraphernalia, Subsequent Offense and Possession of Marijuana. The Commonwealth recommended a sentence of 2 years, which was imposed during a sentencing hearing on November 25<sup>th</sup>, 2009. Haskins was remanded to the custody of the Kentucky Department of Corrections to serve the balance of his sentence.

**Commonwealth v. Kristen Kern**

On August 12, 2009, Kristen Kern pled guilty to four counts of Theft By Unlawful Taking Over \$300, 2 counts of Fraudulent Use of Credit Card Over \$100 within 6 month period, Unlawful Access to a Computer, First-Degree, Unlawful Access to a Computer, Second-Degree, and Forgery, Second-Degree. On November 25, 2009, Kristen Kern was sentenced to five years, to be diverted for a five year period, on the conditions that she make restitution payments and not violate the law.

On November 25, 2009, Sims was sentenced to 3 years, which was probated on the condition that she complete the Drug Court Program.

**Commonwealth v. Michael Taylor**

On August 31, 2009, Michael Taylor entered a guilty plea to Trafficking in Cocaine. On December 2, 2009, Taylor was sentenced to 5 years in prison.

On August 5, 2009, Gloria Powell pled guilty to Bail Jumping for failing to appear for her scheduled sentencing date on August 6, 2008 in Indictment 07-CR-00718. On December 2, 2009, Powell was sentenced to 1 year to serve in prison on the Bail Jumping charge.

On October 3, 2007, Ronnie Wills pled guilty to Second-Degree Assault, Driving under the Influence, Third Offense, and Operating on a Suspended Operator's License. After failing to appear for sentencing due to various issues defendant had in Indiana, on December 2, 2009, Wills was sentenced to 3 years in prison.

**Commonwealth v. Leslie Stovall**

**Police Agency: Christian Co. Sheriff's Office**



On December 2, 2009, Leslie Stovall entered a guilty plea to the amended charge of Facilitation to Unlawful Possession of a Methamphetamine Precursor. Stovall was sentenced to 12 months in the County Jail. Stovall's sentence was probated for a period of 1 year.

**Commonwealth v. Kenneth Wimberly**

On August 8<sup>th</sup>, 2009, Kenneth Wimberly pled guilty to Possession of Cocaine; Possession of Drug Paraphernalia, Subsequent Offense; and Flagrant Non-Support. The Commonwealth recommended a sentence of 8 years, which was imposed during Wimberly's sentencing hearing on

December 2<sup>nd</sup>. Wimberly was remanded to the custody of the Kentucky Department of Corrections to serve the balance of his sentence.

On December 9, 2009, Otis Brison pled guilty to Making a False Statement to Receive Government Benefits Under \$100. His probation will continue until restitution is paid in full.

On December 9, 2009, Kathy McBride pled guilty to Facilitation to Trafficking in Cocaine for driving her codefendant, Herbert Smith, to the transaction location. On December 9, 2009, McBride's 12 month sentence was probated with strict conditions, including that she abstain from drugs and alcohol.

The Commonwealth recommended a sentence of 12 months, and the Court imposed that sentence during a hearing held on that same day. The Court probated that sentence for a period of 12 months.

On October 15, 2009, Walter Mumford entered guilty pleas in two different indictments: (1) 10 years for 2 counts of Trafficking in Cocaine, Subsequent Offense and being a Persistent Felony Offender; and (2) 5 years for Fleeing or Evading Police, Wanton Endangerment, and Terroristic Threatening 3<sup>rd</sup> degree. On December 15, 2009, Mumford was sentenced to 10 years.

The Commonwealth recommended a sentence of 3 years, and the Court imposed that sentence during a hearing on December 15<sup>th</sup>, 2009. The Court probated that sentence for a period of 5 years.

The jury rendered a verdict of guilty on both charges against Vandiver. The jury recommended a sentence of 6 years. During a sentencing hearing on December 15<sup>th</sup>, the Court imposed the sentence of 6 years and remanded Vandiver to the custody of the Kentucky Department of Corrections.

On November 6<sup>th</sup>, 2009, Demarcus McCarley pled guilty to 2 counts of Trafficking in Cocaine. Unusually, the Defendant elected to have the jury set the sentence for his crimes. After hearing evidence about the case, the jury imposed a sentence of 6 years on the Defendant. During a final sentencing hearing on December 15<sup>th</sup>, 2009, the Court imposed that sentence recommendation, and remanded McCarley to the custody of the Kentucky Department of Corrections to serve the balance of his sentence.

During Matlock's sentencing hearing on December 16<sup>th</sup>, 2009, the Court imposed the recommended sentence of 5 years and probated the sentence for a period of 5 years.

**Commonwealth v. David Cummings**

On September 30<sup>th</sup>, 2009, David Cummings pled guilty to 2 counts of Assault, Third-Degree; Knowingly Receiving Stolen Property over \$300; Theft of Motor Vehicle Registration Plates; Fleeing and Evading Police, Second-Degree; DUI, Second Offense, with an Aggravator; Resisting Arrest; Leaving the Scene of an Accident; Disorderly Conduct, Second-Degree; Failure of Owner to Maintain Required Insurance, Second Offense; Operating a Motor Vehicle on a DUI-Suspended License, Second Offense; and Burglary, Third-Degree. The Commonwealth recommended a sentence of 4 years and opposed the Defendant's request



for probation in light of the number and seriousness of his offenses. The Court imposed the 4 year sentence during a sentencing hearing on December 16<sup>th</sup>, 2009 and remanded the defendant to the custody of the Kentucky Department of Corrections to serve the balance of his sentence.

The Commonwealth recommended a sentence of 2 years. The Court imposed the sentence of 2 years during his sentencing hearing on December 16<sup>th</sup>, 2009, and probated and diverted the sentence for a period of three years.

**Commonwealth v. Jennifer Cortner**

On December 16, 2009, Pendleton was sentenced to 10 years in prison.

On September 16, 2009, Chris Duerson pled guilty to Fourth-Degree Assault and First- Degree Trafficking in Cocaine. The trafficking charge resulted from a controlled purchase caught on video of Duerson selling cocaine. The assault stemmed from an altercation with Melody Burrus. On December 16, 2009, Duerson was sentenced to 7 years to serve in prison.

**Commonwealth v. Benjamin Wigley**

She will remain on probation until her restitution is paid in full.

**Commonwealth v. Joshua Justice**

On September 18, 2009, Joshua Justice pled guilty to First-Degree Possession of Methamphetamine, Unlawful Transaction with a Minor, Second-Degree, Possession of Marijuana, Carrying a Concealed Deadly Weapon, and Possession of Drug Paraphernalia. On December 30, 2009, Justice was sentenced to 5 years, which was diverted for 5 years on strict conditions including that he testify against his codefendant in her jury trial.

On September 30, 2009, Anna Jennings pled guilty to 2 counts of

During a sentencing hearing on December 30<sup>th</sup>, 2009, the Court imposed the recommended sentence and remanded the Defendant to the custody of the Kentucky Department of Corrections to serve the balance of the sentence.

**Commonwealth v. Sandra Johnson**

On August 26<sup>th</sup>, 2009, Sandra Johnson pled guilty to Possession of Drug Paraphernalia, Subsequent Offense; Wanton Endangerment, Second-Degree; and DUI, First Offense, with an Aggravator. The Commonwealth recommended a 3 year prison sentence, and the Court imposed that sentence on December 30<sup>th</sup>, 2009. Johnson's sentence was probated and diverted for a period of 5 years.

**Commonwealth v. Charles Pillow**
