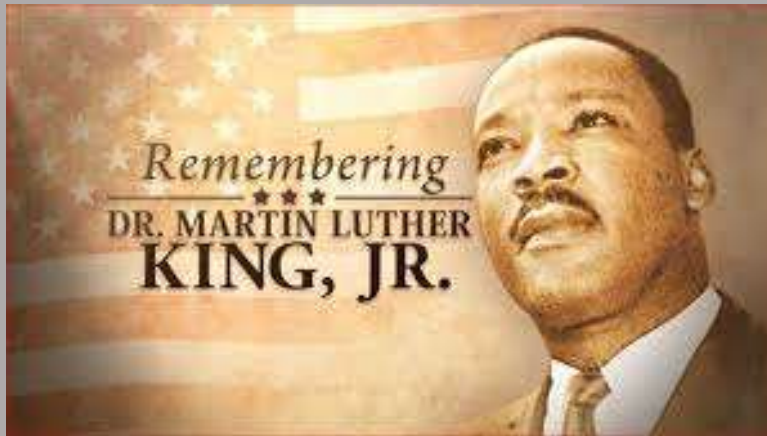

GRAND JURY:

The November-December Grand Jury returned **99** “True Bill” Indictments, **4** “No True Bills,” and there were **2** cases “referred to District Court”.
