## GRAND JURY:

The March-April Grand Jury returned **66** "True Bill" Indictments, **2** "No True Bills," and there were **4** cases "referred to District Court". As always, the Grand Jury was very dedicated and hard-working, and we appreciate their service to our community. Their report is attached under the Grand Jury tab on our website.

## COURT PROCEEDINGS:

From March 1, 2018, through April 30, 2018, our office handled **127** arraignments, **125** probation revocation hearings, and **133** sentencing hearings.

## JURY TRIALS:



### COMMONWEALTH V. WESLEY BANKS

On March 5<sup>th</sup> and 6<sup>th</sup>, 2018, Assistant Commonwealth's Attorney Maggie Gigandet tried the case of Commonwealth v. Wesley Banks. Banks was charged with three counts of Sexual Abuse, First Degree, Victim under 12 years of age. These charges were based on allegations that Banks made sexual contact with two boys under the age of 12 between January 15, 2015 and April 15, 2015. One count was for B.C., and two counts were for N.W. Both B.C. and N.W. testified and told the jury how Banks groped their private parts. B.C. also testified about how Banks tattooed him on his ankle. The jury found Banks guilty of all three counts of Sexual Abuse, First Degree. The jury recommended a sentence of ten years imprisonment. The Defendant will be sentenced on July 11, 2018.

On April 23, 2018, Assistant Commonwealth's Attorney Katherine Foster tried the case of Commonwealth v. Desiree Catlett. The defendant was charged with Manslaughter, Second Degree, in connection with the death her infant son. After hours of deliberation the jury was unable to come to a unanimous verdict thereby resulting in a hung jury. The case has been scheduled for a pretrial conference on May 16, 2018.

On April 26, 2018, Assistant Commonwealth's Attorney Maggie Gigandet tried the case of Commonwealth v. Antonio Sallee. In his Indictment, the defendant was charged with Sexual Abuse, First Degree, victim under 12 years of age; Unlawful Transaction with a Minor, First Degree, victim under 16 years of Age; Indecent Exposure, First Degree, First Offense; Sodomy, First Degree, victim under 12 years of age, 2 Counts; Rape, First Degree, victim under 12 years of Age, 2 Counts; Incest, victim under 12 years of age, 2 Counts; and Persistent Felony Offender, First Degree. After hours of deliberation, the jury was unable to come to a unanimous verdict on the charges on which they were instructed by the Court thereby resulting in a hung jury. The case has been scheduled for a pretrial conference on May 23, 2018.
