## **Blind Justice** **By the Victim's Advocate**

As I scanned the courtroom while waiting for the bailiff to say, "All rise", I noticed a lady sitting alone, head down. She seemed nervous and was visibly shaking. I started to go over to make sure she was alright, when the bailiff entered the courtroom and announced that court was now in session.

After several names had been called, new court dates assigned and pleas entered, the judge scanned his paper for the next case. As the defendant's name was called, I saw her lift her eyes slightly and watched as she glanced toward the door to the holding cells. I could hear the clanking of the ankle chains as he made his way to the door, finally in sight of the courtroom. Her hand shook as she raised it to her mouth to stifle a gasp. He searched the audience, as most of them do, trying to find the familiar face of a friend or family member. She froze. Was he looking for her? This person who took the love of her life, her best friend or possibly her young child, how could he be looking for her?

"Good morning Mr. Smith. How are you today?" the judge said as the defendant reached the bench.

"Fine your honor, and you?" he replied in a strong, steady voice.

"I'm good now let's get down to business, shall we." The discussion between the prosecutor and the defense attorney went back and forth for several minutes. She strained to hear, but not wanting to sit up front where she could be seen, she couldn't make out what was being said. Finally business at hand was complete, and the defendant made his way slowly back across the room. Before disappearing inside the dark corridor to the holding cells, he turned toward the audience and smiled. On the second row, an elderly man returned the smile, stood and walked out of the courtroom.

Finally I was able to walk over to her, introduced myself and asked if she was alright. She was still shaking, tears streaming down her cheeks. Barely able to utter the sounds, she asked, "He turned and smiled at me. Why would he do that? Does he know who I am?"

"I don't think so. I saw an elderly man sitting close to the front smile back at him."

“The judge was so nice to him, how could he be so nice to ...,” her voice trailed off and she started to sob. She took a deep breath, trying to compose herself. “You’re the only one who has come over to me. The judge didn’t speak to me or even ask if anyone from the family was here.” I then explained to her the various paths a case can take, wanting to let her know how much time can pass before she might have some sort of closure. As I finished she stood, smiled slightly and said, “Seems a bit one sided to me.”

Lady Justice has stood tall for decades in the lobbies or courtyards of justice centers across the United States as a symbol of “justice for all.” Her body is adorned with items to serve as a constant reminder of what she stands for. Head held high, she stands blind folded, depicting that all men are equal in the eyes of the law, regardless of social or financial status.

With a strong, steady hand she holds the scales of justice firm, keeping them balanced to signify that each man or woman gets no more or no less than what they deserve for the crime they have committed. By her side, her other hand rest on a double edged sword representing the power of reason and justice - the power that one holds when rendering a verdict.

In the eyes of most, the legal system is far from perfect. Not guilty verdicts have been handed down, when some jurors felt in their heart that the defendant had committed the crime, but the evidence presented wasn’t enough to warrant time in prison. So where does that leave the victims and their families? For them the scales of justice are never balanced. If they tilt in favor of prosecution, the defendant has a right to appeal the jury’s decision in a desperate attempt to bring back the balance of justice. If it tilts in favor of the defendant, the victim and their families having no right to an appeal, and they will have to live with that decision for the rest of their lives.

It’s a lot to take in, in a short span of time. As the verdict is read, each word spoken carries with it a weight too heavy for them to bear. Numbed by what they have just heard, they rise slowly from their seats, trying to make their way to the door. A grief stricken mother glances back over her shoulder in hope of finding something that she can draw strength from. By now, the jury box is empty. The judge has vacated the bench, and the crowd has begun to clear. In the far corner, just behind the prosecutor’s table, she sees the clerk taking down the enlarged photo of her son. She watches, tears blurring her vision, as he gently places the photo in a box.

We don’t see what happens next for them, what takes place in their lives, or how they manage to adjust. We’re not there when they completely fall apart. Maybe there’s another reason why Lady Justice is blind folded. Perhaps she can’t bear to see how some peoples’ lives are shattered by the dispassionate system that she has represented for so many years.

## Safety Tips from Commonwealth's Detective Kenny Over

### *Reducing Violence*

- Look for alternatives to settling disagreements and arguments without violence (including yelling). Children follow our example - be a good role model.
- Use good manners to help ease tensions that can lead to violence.
- Teach kids that respecting themselves and others can prevent crime.
- Report crimes and suspicious activities to police. Agree to testify if necessary. If you want to live in a safe community, stand up for what you believe in.
- Don't support illegal activities such as buying possible stolen property. It only encourages more crime.
- Be aware of what is going on in your community; read the paper, listen to the radio, & avoid areas where violent crimes are reported.

### JURY TRIALS:



#### **COMMONWEALTH V. MANFORD GIRTEN**

On May 20<sup>th</sup>, 2010, Manford Girten was tried on the charge of Trafficking in a Controlled Substance Within 1000 Yards. Officers of the Hopkinsville Police Department responded to a call from an individual named Robin Melcher, who stated that Mr. Girten had broken into his home. Upon arrival, Mr. Girten was discovered to be asleep in Mr. Melcher's bed. Officers subsequently found in plain view approximately 4 grams of marijuana in individually-wrapped plastic bags along with other items of drug paraphernalia. Mr.

Melcher later pleaded guilty to Falsely Reporting an Incident and Possession of Drug Paraphernalia, Subsequent Offense. Mr. Melcher testified at trial that the marijuana belonged to Mr. Girten. Mr. Girten was subsequently acquitted.



**COMMONWEALTH V. CHARLES CARDWELL**

On May 24, 2010, the case of Commonwealth of Kentucky vs. Charles D. Cardwell was tried by Kathi Adams before a jury in Christian Circuit Court on May 24, 2010, on three counts of Sexual Abuse, 1<sup>st</sup> Degree on a minor under 12 years of age. Witnesses for the Commonwealth included two children (victims), their legal guardian, forensic physician Dr. Calhoun, and investigating officer Ken Roberts from the Christian County Sheriff's Office. All the witnesses' testimony alluded to sexual touching of victims by Defendant in 2006 - 2007 at Defendant's trailer. Although Dr. Calhoun testified that there was physical evidence that the female victim had been sexually abused, there was also evidence that these children had been in foster care since infancy, and had been placed in several homes until the present. Inadmissible to the jury was that Cardwell pled guilty to a similar offense in Texas 20 years ago, and that he is presently facing other felony charges in Christian County for driving his vehicle while under the influence, crashing it, and causing injuries to the small child in the car with him. The jury returned a verdict of not guilty on all counts. The children are currently in very safe homes in the Lexington area. Cardwell's other felony case is set for jury trial 9/16/10.



**COMMONWEALTH V. DEVIN KEELER**

On June 7, 2010, Commonwealth's Attorney Lynn Pryor tried the case of Commonwealth v. Devin Keeler. Ramona Lapradd, a co-defendant and Keeler's live-in girlfriend, was also scheduled for trial on this date; however, she decided to enter a guilty plea on the morning of trial. The Commonwealth proceeded with the case against Keeler and presented evidence that he and Donald Grace had been manufacturing methamphetamine in various locations for months. Det. Berghammer and Jailer Brad Boyd had located a large quantity of starting fluid, as well as other items used to manufacture methamphetamine, including tanks that had been modified to contain anhydrous ammonia. There was also a stolen four-wheeler and a homemade pipe bomb located on

Keeler's property as well. The jury found Keeler guilty of Manufacturing Methamphetamine, Possession of Anhydrous Ammonia in an Unapproved Container to Manufacture Methamphetamine, Knowingly Receiving Stolen Property, Use of a Booby Trap Device and Possession of Drug Paraphernalia. The jury recommended a 19 year sentence for Keeler. Keeler and Lapradd will be formally sentenced on August 10, 2010, by Judge John Atkins.



#### **COMMONWEALTH V. RONNIE FORTE**

On June 7, 2010, the case of Commonwealth of Kentucky vs. Ronnie Forte was tried by Kathi Adams before a jury in Christian Circuit Court on June 7, 2010, on one count of Rape, 1<sup>st</sup> degree. Witnesses for the Commonwealth included the victim, an Emergency Operations Center Audio Recording, and Detective Randall Greene from the Hopkinsville Police Department. The facts were that the Defendant met the victim in Fall 2008, while she was in Sanctuary House, quickly moved her into his home, gave her money, drugs, and his food stamps. They had sex on occasion. On a particular day in Spring 2009, the victim testified that Ronnie grabbed her, and forced her to have sex with him after she said no. She had dialed 911, and the recording was played at trial—which confirmed her screaming “no” to Defendant. Ronnie Forte also took the stand in his own defense, and he testified that the two had an ongoing sexual relationship and that he gave her cocaine, pills, money, and food stamps for sex and other favors. The jury returned a verdict of not guilty. Ronnie Forte is currently facing felony charges for misappropriation of food stamp benefits.



#### **COMMONWEALTH V. NOLAN HOOPER**

On June 8<sup>th</sup>, 2010, Nolan A. Hooper was tried on the charges of Knowingly Receiving Stolen Property Over \$300 and Theft By Deception Over \$300. Officers of the Oak Grove Police Department recovered a stolen 60 inch Kubota zero turn mower on the property of Ms. Karen Hale approximately 13 months after the mower was stolen from The City of Oak Grove. Ms. Hale testified that the Defendant procured the mower for her for approximately \$2,500. Mr. Hooper was subsequently acquitted.

**COMMONWEALTH V. STEVE MCGLONE**

**Charges:** 1<sup>st</sup> Degree Sexual Abuse  
**Disposition:** Guilty 5 years prison.

On June 21, 2010, the case of Commonwealth of Kentucky vs. Steve McGlone was tried by Kathi Adams before a jury in Christian Circuit Court on June 21, 2010, on two counts of Sexual Abuse 1<sup>st</sup> Degree, Victim under 12 years of Age. Witnesses for the Commonwealth included the minor victim, her teenage sister, her father Alex McGlone, physician Dr. Calhoun, Pennyrile Children's Advocacy Counselor Kristy Patterson, and Detective Randall Greene of the Hopkinsville Police Department. Alex testified that when his father, the Defendant, was temporarily living with Alex & his family, he walked in on the Defendant sexually abusing his 6 year-old daughter. Alex also testified that he promptly had his father removed from the home, got an Emergency Protection Order, and sought necessary treatment for the family. Alex reported it to police after speaking with his daughters about past incidents. At trial, both the minor victim, and her teenage sister testified that Defendant would often take the victim into his room alone, and lock the door. Dr. Calhoun testified that there was vaginal scarring consistent with the minor victim's recount of the incidents. The jury returned a verdict of guilty on one count of Sexual Abuse, 1<sup>st</sup> Degree, and sentenced Steve McGlone to 5 years in the penitentiary. Because Sexual Abuse 1<sup>st</sup> Degree is a violent offense, and requires sex offender treatment, McGlone will have to serve at least 85% of his sentence before parole eligibility. Once he is released, he will be a lifetime sex offender registrant.



## COMMONWEALTH V. TRUMAINE MANCHOUCK

On June 28, 2010, Commonwealth's Attorney Lynn Pryor tried the case of Commonwealth v. Trumaine Manchouck.

Manchouck was accused of murdering Chrisphine "Jerry" Walter on April 1, 2007 in Oak Grove, Kentucky. The jury heard from several witnesses over the course of two days, including testimony from the two eyewitnesses who were in the car with Manchouck when he stuck his arm out the window and shot an unarmed Walter. However, the jury was unable to reach a unanimous verdict after being given the options of finding him guilty of murder, second-degree manslaughter or reckless homicide. The "hung jury" resulted in the Court declaring a mistrial. There is a pre-trial conference scheduled for July 28 to either resolve the case or schedule a date for the re-trial of this matter.

### GUILTY PLEAS/SENTENCINGS:

This section of our Newsletter includes a brief description of sentencing hearings that took place during the previous two-month period. While many consider "plea-bargains" as a negative way to resolve cases, defendants typically plead guilty to the same charges they are indicted for. When the defendant is sentenced following a guilty plea, they stand convicted of the charges just as if a jury had found them guilty. Therefore, the only thing they bargain away is their right to a jury trial and right to appeal. You will also see the jail-intake photos of these Defendants, when available.

Once the Commonwealth makes an offer and the Defendant enters a guilty plea, it is up to the Circuit Judge to determine if the Defendant will be probated or sentenced to prison. Another option that the judge has is one that must be agreed upon by the Defendant and by the Commonwealth – Pretrial Diversion.

**Pretrial Diversion:** Kentucky Revised Statutes allow for a person to be placed on a "Pretrial Diversion" under certain circumstances. 1) All charges which they are pleading guilty must be Class D felonies (1-5 years); 2) The person must enter a plea of guilty, or a plea pursuant to *North Carolina v. Alford* before becoming eligible for pretrial diversion; 3) Persons ineligible for probation, parole or conditional discharge under KRS 532.045 shall be ineligible; 4) a person convicted of a Class D felony for which early release is disallowed by statute including KRS 189A.010(8) and KRS 189A.120(2) [DUIs] shall be ineligible 5) No person shall be eligible for this program more than once in any five (5) year period. A person who is placed on diversion is considered a convicted felon during the period of their diversion and is subject to the same conditions as someone who is on felony probation. If someone completes that period of diversion/probation without any infractions or

new charges, they can move the court to have their case dismissed/diverted, and they are no longer a convicted felon.

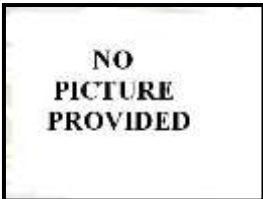

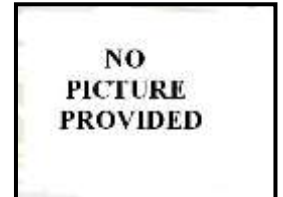

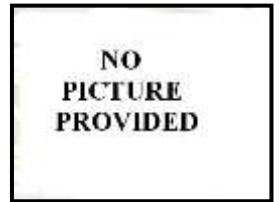
