

Article VI: Officers

Updates to align with current operations and to promote succession of qualified candidates.

• **Section 1**

- *Proposed:*

The officers of this local PTSA shall be:

Executive Treasurer

President – Elementary School

Vice President – Elementary School

Secretary – Elementary School

Treasurer – Elementary School

President – Middle School

Vice President – Middle School

Secretary – Middle School

Treasurer – Middle School

President – High School

Treasurer – High School

- *Current:* The officers of this local PTSA shall be a president, a vice president for each school level, an executive secretary, an executive treasurer and assistant treasurer for each school level.

• **Section 7**

- *Proposed:* There shall be a nominating committee composed of 3 members who shall be approved by the general membership of this local PTSA at a regular general membership meeting at least 3 months prior to the election of officers, as outlined in Article VI, Section 2.
- *Current:* There shall be a nominating committee composed of 3 members who shall be elected by this local PTA at a regular general membership meeting at least six month prior to the election of officers, as outlined in Article VI, Section 2.

• **Section 7b**

- *Proposed:* The nominating committee shall nominate at least one eligible person for each office to be filled and report its nominees to the membership in advance of the election. Additional nominations may be made from the floor at the election. A thirty-day notice of the June election meeting, including the slate of officers to be presented, must be given to the membership.
- *Current:* The nominating committee shall nominate at least one eligible person for each office to be filled and report its nominees at the regular general membership meeting in May, at which time additional nominations may be made from the floor. A thirty-day notice of the meeting, including the slate of officers to be presented, must be given to the membership.

Article VII: Duties of Officers

 - d. Have checks signed by two people: the treasurer and one other person;

Article VIII: Executive Committee

• Section 1

- *Proposed: The executive committee shall consist of the 4 Executive Officers, 3 Presidents, and 3 Treasurers, Administration representative, the School Committee representative, and the president of the Holliston Federation of Teachers or designee.*
- Current: The executive committee shall consist of the elected officers of Holliston PTSA, Administration representative, the School Committee representative, the president of the Holliston Federation of Teachers or designee, and Chairs of the Subcommittees of Parent Education, Newsletter, Fundraising, Culture Connection, Membership.

Article IX: Committees

Section 2

- *Proposed: The standing committees of this local PTSA shall be, but not limited to: Culture Connection Committee, Membership Committee, Fundraiser Committee, Parent Education Committee, Reflections Committee, Technology Committee, Public Relations Committee, Ski Club, Destination Imagination.*

Special committees may be established for ongoing activities throughout the year that involve more than one school level.

- Current: The standing committees of this local PTSA shall be, but not limited too: Culture Connection Committee, Membership Committee, Fundraiser Committee, Parent Education Committee, Reflections Committee, Newsletter and Website Production Committee, Special Committees* - Ski Club, Destination Imagination, Parent Network.

*Special committees are established for ongoing activities throughout the year that involve more than one school level.
