### Temporary Partial Disability (TPD) (Post 2/2006)

Due when employee returns to job earning less than earnings prior to injury.  
(Ex. prior earn \$375 and current earn \$300 = \$50 weekly TPD or 2/3 of \$75 differential)

Carpal Tunnel due to repetitive trauma for accident after June 28, 2011 capped at 15% of hand unless clear and convincing evidence raises to high cap of 30% both using 190 weeks as 100% of hand.

Wage differential claims for dates of loss after September 1, 2011 are capped at the greater of claimant reaching 67 years of age or 5 years of benefits.

POST 2/2006 PUBLISHED MINIMUM TTD/PPD \*\* not to exceed the average weekly wage\*\*

### MINIMUM DEATH BENEFIT AFTER 2/2006

GREATER OF \$500,000 / 25 YEARS COMPENSATION  
Current MINIMUM = \$538.19 x 52 x 25 or \$699,647.00

MINIMUM RATE FOR DEATH, AMPUTATION, ENUCLEATION AND TOTAL PERMANENT DISABILITY EQUAL TO 50% OF STATEWIDE AVERAGE WEEKLY WAGE OR:
