## GENERAL TERMS OF HIRE

The minimum hire is half day, after that an hourly rate applies. Your time starts when you enter the studio (bump in) to when you leave the studio (bump out) and is accorded to the time that you actually booked. This does not take into account if you are late arriving.

Half-day hire can start at any time in the morning as long as bump out time is before 1:30 pm. The afternoon half-day can begin any time after 1:30 pm. Full day hire can begin at any time. Evening hire is available. Weekend hire attracts a \$50 plus GST surcharge.

The studio is 160 m2 in total with the shooting area measuring 6 x 13 meters taking in a south/west corner featuring 3 large windows measuring 5.5 x 3 meter windows, and a ceiling height of 4.25 m.

There is a separate make up, kitchen and client waiting area. The building also has a café on the ground floor, which will cater for your shoots if required.

The studio hire charges include the use of the above areas as well as the furniture in the shooting area's lounge setting. There are other chairs, props, background and equipment available for hire (see attached list for prices).

The full use of the kitchen is charged at an extra \$150 for half or \$275 for full day hire.

**The Studio is to be left in the same condition as found, otherwise a cleaning fee of \$95 will be charged.**

Sydney Photography Studio has insured the studio premises against all normal insurable risks but not further or otherwise. Should any part of the property or hired equipment be damaged due to negligence then The Hirer will be charged the repair or replacement cost.

The Hirer is responsible for insuring their own equipment and personal property and that belonging to their clients, assistants, associated personnel and other third party individuals.

Please ensure that your public liability insurance covers you whilst using Sydney Photography Studio. The Hirer agrees to indemnify Sydney Photography Studio against any costs including legal costs, damages, payments, fines, or interests Sydney Photography Studio may incur as a result of the Hirer breaching this agreement.

Sydney Photography Studio reserves the right to terminate this agreement at any time with or without notice if the Hirer has breached any terms of this agreement or for reasons of force majeure.

Payment must be made in full upon confirmation of booking. The Studio will place a hold on a proposed booking day but will only confirm the booking upon full payment (this includes but is not limited to, any equipment hire or studio overtime rates). We have a no refund policy.
