These guidelines are provided to describe categories, fees and requirements.
Any applicant not meeting necessary requirements will be ineligible to participate in TNMP.

FOOD VENDORS

- All food vendors with a business in good standing within the BID (see BID map) will pay 10% of their **nightly gross sales**, with a minimum payment of \$27.00/night. If a vendor earns less than \$270.00 on any given night, they must still pay the minimum payment of \$27.00/night.
- Food vendors located outside the BID (see BID map) must be approved and will pay 10% of their **nightly gross sales**, with a minimum payment of \$32.00/night. If a vendor earns less than the \$320.00 on any given night, they must still pay the minimum payment of \$32.00/night. Business shall be determined not to be similar, related, and/or a competing business with any business or organization that is a BID member and participating in the Thursday Night Market Place.
- Must supply a copy of:
 - Application
 - Liability insurance (1 million dollar general aggregate) with Main Street Hanford listed as an "Additional Insured"
 - Health Department Permit (contact number 584-1411).

Note: Barbeque vendors needing more space than the assigned 10ft x 10ft, will need approval and will be charged an additional \$20.00/night per 10ft x 10ft. This nightly fee is in **ADDITION** to the minimum nightly fee.

CERTIFIED GROWERS

- All certified growers will pay 10% of their nightly gross sales, with a minimum payment of \$22.00/night. If a certified grower earns less than \$220.00 on any given night, they must pay the minimum payment of \$22.00/night.
- Note: Growers paying for an additional space for \$20/night will need approval and will be charged an additional \$20.00/night (minimum of \$42.00/night).
- Must supply a copy of:
 - Application
 - Liability insurance (1 million dollar general aggregate) with Main Street Hanford listed as an "Additional Insured"
 - Certified Produce Certificate

ALL OTHER VENDORS

MEMBERS/\$27.00 *(10% discount if paid in full by April 13th)*

- Must be a business in good standing in our Business Improvement District (BID). See BID map.
- Must supply a copy of:
 - Application
 - Copy of Business License
 - Liability insurance (1 million dollar general aggregate) with Main Street Hanford listed as an “Additional Insured”

NON-MEMBERS/\$42.00 *(10% discount if paid in full by April 13th)*

- Business shall be determined not to be similar, related, and/or a competing business with any business or organization that is a BID member.
- Must supply a copy of:
 - Application
 - Copy of Vendor Resale License
 - Liability insurance (1 million dollar general aggregate) with Main Street Hanford listed as an “Additional Insured”

NON-PROFIT/\$27.00 *(10% discount if paid in full by April 13th)*

- Must supply a copy of:
 - Application
 - Liability insurance (1 million dollar general aggregate) with Main Street Hanford listed as an “Additional Insured”
 - Must supply a copy of non-profit status from the IRS

MAKERS-CRAFTERS/\$27.00 *(10% discount if paid in full by April 13th)*

- Must supply a copy of:
 - Application
 - Liability insurance (1 million dollar general aggregate) with Main Street Hanford listed as an “Additional Insured”
 - Photos of items to be sold
