Instead of a late fee, you will be responsible for your
own gate admission. **No field entries.**

Rules and regulations

1. The competition will be governed by the Rules and regulations of the SOBHD.
2. **THERE WILL BE NO REFUNDS OF ENTRY FEES - NO EXCEPTIONS.**
3. Competitors must show current SOBHD card to receive awards. ANY dancer that forgets their card must provide a copy of it within 10 days, along with a fee of \$10.
4. Cash prizes for Premier 16 years and over, **1st - \$50, 2nd - \$40, 3rd - \$30, 4th - \$20**
5. The competition committee reserves the right to combine, split or delete classes at the close of entries.
6. The decision of the judge is final. No persons other than the competition committee shall communicate with the judge.
7. Protests must be made in writing, signed and submitted to the competition secretary before the end of the competition with a \$30.00 fee. Fee will be refunded if the protest is sustained.
8. Dancers must remain in costume to receive awards.
9. Dancers will dance in inverse order of entry.

11. The competitor's age is taken as of the competition date.
