<ul style="list-style-type: none"> SOBHD & FUSTA rules will be followed. Last to enter, first to dance. All dancers must have a valid 2018 FUSTA, Scotdance, or SOBHD registration card. Any dancer not on hand when their event takes place will forfeit their entry in that event. Dancers who are registered for 2018, but do not have their valid card with them, may dance. However, all dancers without cards must send a copy of their card to the organizer within 10 days following the competition. Any awards won will be held until the card is received. Age groups will be determined after entries are received. Organizer reserves the right to combine, split, or delete classes the day of the competition. Cash awards for Premier 16 & Over will be \$30, \$25, \$20, \$15. Change in classification must be received prior to March 1, 2018. Margo Naismith Memorial Award; Special Event. Cash Prizes will be awarded to 1st, 2nd and 3rd place; Donated by Campbell Naismith 	<ul style="list-style-type: none"> All entries must be postmarked by March 10, 2018. Entries postmarked or phoned in after must be accompanied by a late fee of \$10.00. This is a non-refundable entry fee. All dances count towards the trophy. \$2 of each entry will go to FUSTA. The organizer reserves the right to make changes to any information and times given in the entry form if necessary. Communication by a dancer or parent of a dancer with the judge or piper is not allowed and is grounds for disqualification. All winners must be in competition dress to accept awards. Judge's decision is final. <p>All protests must be in writing, signed, and handed to the organizer by the end of the competition, accompanied by a \$30 fee that will be refundable if the protest is sustained.</p>

I acknowledge that my activities hereunder are a "work made for hire" within the meaning of the U.S. copyright laws. Without limiting the foregoing, I further grant to ASICS the right to adapt, change, edit, modify, add to, delete, reproduce, distribute and otherwise distribute the same in any manner and any method now known or hereafter devised. I represent and warrant that I have the right to grant the consent above and that no further consents or releases are required by ASICS in order for it to make use of the photos and/or videos produced by ASICS. I realize that ASICS is relying upon this Release, which is at substantial cost to ASICS. I hereby agree that I will not assert or maintain against ASICS any claim, action, suit or demand of any kind or nature, whatsoever, including, but not limited to, those grounded upon invasion of privacy or of publicity or any other civil rights, defamation, libel or slander or for any other reason in connection with the exercise of the rights granted herein to ASICS.

ACTIVITY AND ASSUMPTION OF THE RISKS: I acknowledge and understand that the Activity in which I am engaging is or may be of an inherently dangerous nature and by engaging in this Activity, I may be putting myself at risk of serious injury or death. I understand that I may be exposed to certain hazards in the course of the Activity (depending on the nature of the Activity), including overexertion, overheating, injuries from my lack of fitness or conditioning, equipment failures, and negligence of others. I hereby freely assume the above-mentioned risks and any harm, injury or loss that may occur to me or my property as a result of my participation in the Activity -- including any injury or loss caused by the negligence of ASICS (its employees), any other sponsor/providers, and other Activity participants. I also understand that any equipment or materials are provided by ASICS without any warranty about its condition or suitability. I acknowledge that I am engaging in the aforementioned activity solely of my own accord.

RELEASE OF LIABILITY: In consideration of being permitted to participate in the Activity, I accept and agree to the full contents of this Release and hereby irrevocably release ASICS, the sponsors/providers of any equipment used in the Activity, and each of their respective employees, officers, and directors (the "Released Parties") from and against ALL LIABILITIES, CAUSES OF ACTION, CLAIMS, DAMAGES, DEMANDS, COSTS AND EXPENSES that arise in any way from any injury, death, loss or harm that occurs to me or to any other person (e.g., child) or to any property during the Activity or in any way related to the Activity. I also agree NOT TO SUE or make a claim against the Released Parties for death, injuries, loss or harm that occur during the Activity. This includes any claim of any minor I permit to engage in the Activity and any claim arising from the negligence of the Released Parties. This Agreement shall be governed by the laws of the State of California applicable to agreements executed and to be fully performed therein (without regard to the conflict of laws provisions thereof). I hereby irrevocably waive any and all rights to seek or obtain any injunctive or other equitable relief against ASICS. I acknowledge and agree that any breach by me of this Agreement will cause ASICS irreparable harm, and therefore, that ASICS shall be entitled to injunctive or other equitable relief in addition to all other remedies available at law or in equity, in any court of competent jurisdiction (with no obligation to post any bond or surety).
