## GENERAL PRICE LIST

These prices are effective as of January 15, 2016, and are subject to change without notice.

The goods and services shown in this brochure are those we can provide to our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our services. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral services and merchandise you selected. This list may not include prices for certain items that you select, such as cemetery charges or crematory services, flowers and newspaper notices. The estimated or final prices for those items will be shown on the itemized statement describing the funeral services in buying certain items.

Your authorization is required for a funeral home to obtain custody of a body, and a body must be released promptly upon your request. The provider of funeral services is required to give price information in person and over the telephone. A provider of funeral services is prohibited from representing that the deterioration of human remains can be prevented for more than a limited time by embalming, casket, vaults or outer interment receptacles.



**PLEASE NOTE:** This establishment is one of a select number of funeral homes who meet the criteria for providing green funeral service by the Green Burial Council—a tax exempt, nonprofit organization working to encourage environmental sustainability in the field of funeral service. These offerings allow for a funeral to take place without the use of toxic or non-biodegradable materials/chemicals. Caskets and shrouds are made available to enclose and transport the dead. Body preparation suitable for a green funeral service accommodated by this funeral home consists of the use of topical sprays/compounds, or arterial embalming with essential oils. Home wakes, public visitations, church and synagogue funerals as well as graveside services are options that may be arranged within the time frame that a green funeral allows.

## ALTERNATIVE SERVICES

The following charges for direct burial and direct cremation do not include additional items or services, merchandise, facility use, and livery that the customer may wish to select.

## DIRECT CREMATION

Direct Cremation prices range from \$1,495\*, which includes the basic local transfer of remains to the crematory, the funeral director and staff services, securing of necessary authorizations, an alternative container for cremation, and the return of the cremains to the funeral home, to \$1,300 \*, which includes the services as described above but with the cremation container supplied by the customer. If you want to arrange a direct cremation, you may use an unfinished wooden box or an alternative container. Alternative containers can be made of heavy cardboard, pressed wood or composition materials (with or without an outside covering), or may be pouches of canvas or other materials.

*\*Direct cremation prices do not include crematory charge.*

## DIRECT/IMMEDIATE BURIAL

Prices range from \$2,395\*, which includes the local transfer of the remains to the funeral home, staff services, securing of necessary authorizations, basic local transportation to the cemetery, in an alternative container, to \$2,200\*, which includes the services as described above but with the container supplied by the customer.

*\*The direct burial prices do not include cemetery charges.*

## TRANSFER OF REMAINS TO THE FUNERAL ESTABLISHMENT

- Within the five boroughs of N.Y. City: \$595
- Add \$100 from Nassau County
- Add \$ 4 for each additional mile outside of the five boroughs of New York City from the funeral home
- Extra man/men on Removal: \$100

## PREPARATION OF REMAINS INCLUDING USE OF PREPARATION ROOM

Embalming: \$595\*

*\*In New York State, embalming is not required by law. If you do not want embalming, you have the right to choose an arrangement which does not require you to pay for embalming such as direct cremation or direct burial.*

## OTHER PREPARATION INCLUDING USE OF PREPARATION ROOM BUT EXCLUDING EMBALMING

- Topical Disinfection: \$125
- Dressing & Casketing: \$295
- Cosmetology: \$95
- Restoration: \$500
- Custodial Care: \$195\*

Preparation of the remains, unless selected, is not required for direct cremation or direct burial.

*\*Custodial care will not be charged on the days when embalming or other preparation of the remains occurs, visitation is held or a funeral service is conducted.*

*\*\*If remains are to held at our establishment in excess of six (6) hours, our firm requires refrigeration (you may select embalming, instead).*

## ARRANGEMENTS/BASIC SERVICES OF FUNERAL DIRECTOR & STAFF



The charge for our services will be added to the total cost of the funeral arrangements you select. However, this charge will not be added to the cost of direct cremation, direct burial, forwarding of remains or receiving remains because the prices for those services include this charge.

Basic Arrangements begin at \$1,295, which includes funeral director, other staff, equipment and facilities to respond to initial request for service, the arrangement conference, securing of necessary authorizations and coordination of service plans with parties involved in the final disposition of the deceased.

- Supervision for Funeral Service (cemetery graveside or crematory): \$675
- Supervision for Home Funeral Vigil Service: \$950 first day, \$250 each additional day up to three

- Supervision for Interment of Cremated Remains: \$675

### FORWARDING REMAINS TO ANOTHER FUNERAL HOME: \$2,195

This charge includes the local transfer of the deceased to the funeral establishment, the services of the funeral director and staff, securing necessary authorizations, local transportation to point of shipment. This charge does not include shipping charges or additional of services, merchandise, facility use and livery that the customer may wish to select. Transportation beyond local point of shipment will be billed either as livery or common carrier charges depending upon the forwarding location. Local point of shipment is up to or within New York City.

### RECEIVING REMAINS FROM ANOTHER FUNERAL HOME: \$1,895

This charge includes basic local transportation of the remains to the funeral establishment and/or place of local disposition, the services of the funeral director and staff, securing necessary authorizations. This charge does not include additional items of services, merchandise, facility use, and livery that the customer may wish to select.

Transportation beyond a local place of disposition will be billed as livery charges. Local place of disposition is up to or within New York City.
