Judy will have trash bags and gloves available at the Islamorada chamber if any teams need them.

Judy has stickers available to hand out to participants. She will also provide a dozen pink and/or white hats to each area.

Mike reminded everyone to take photos of the volunteers with their hats on and send them to Judy.

At the October meeting Mike will share the Annual Report for review. It is due Nov 11.
