#### New Business.

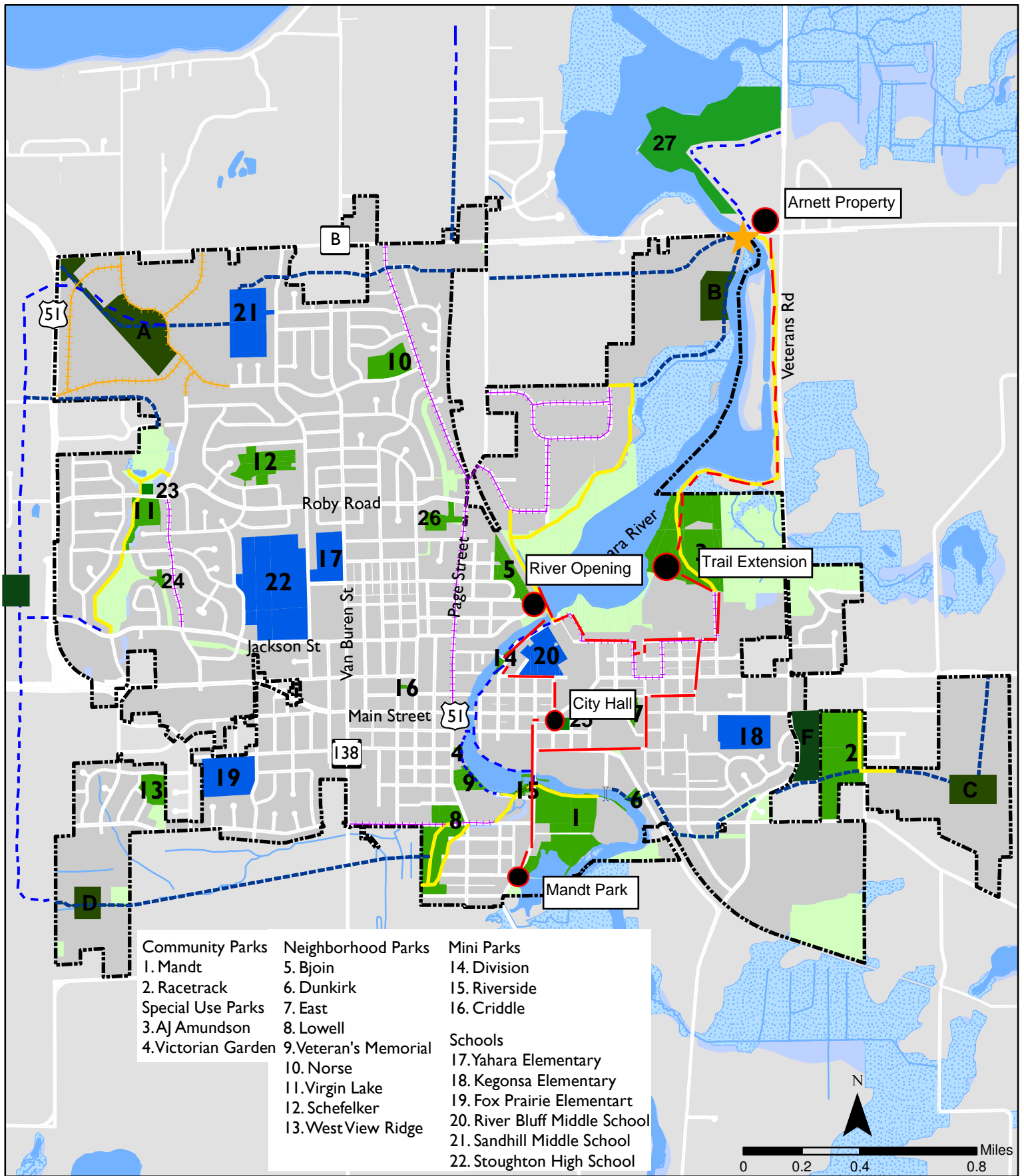
7. Disc Course Expansion: There is room for expansion. Joni will check with Kiwanis.
