Call to Order

- 1. Call to Order at 5:32 pm.
- 2. July 6, 2015 Minutes. Motion by Sandra, second by Bob to approve. Carried. July 21, 2015 Minutes. Motion by Joni, second by Sandra to approve. Carried.
- 3. Communications: Larry mentioned that the city did cut locust trees along the roadway by the millpond but they were not sprayed.

Old Business

- 4. Division Street Park Riverbank Restoration Update. The plan by Aaron Steber of Cardno was approved at Parks and Recreation Committee and will be sent to Finance Committee on September 22, 2015 and then to the Council. Once the plan is approved, a final plan with details will be shared.
- 5. Amundson Trail Update. The grant application is due at the end of the month for the section of trail from Amundson Park to the hospital. The hospital would then complete the trail down to the start of the paved path. The easements have been sent to the City Attorney for approval.
- 6. Amundson Trail Loop Update. Tom provided pictures today with two sections, one that has a clear path and one that needs mowing.
- 7. Helen Johnson Trail Update. Per policy, it has almost been 30 days for public awareness of the naming and then it moves onto Council for approval.

New Business.

- 8. Future Projects. (1) Discussed the Arnett Trail. (2) With the delay of the Hwy 51 bypass which would have closed the bridge on Hwy B over the Yahara River, there was discussion of adding a pedestrian crosswalk to the present bridge.
- 9. Future Agenda Items. (1) Regina mentioned planting flowers next to the trail along the river in Mandt Park. (2) Discussed spending the spring clean-up time clearing brush on the trail to view the river versus clean-up as past years have cleared much of the waste.

Adjournment. Motion by Ralph with a second by Bob to adjourn at 6:20 pm. Carried.
