



## Important Notices



### **Child Passenger Restraint (A.R.S. 28-907A)**

Purchase of a child passenger restraint system after the date and time the complaint was issued **May** result in a reduced sanction. Contact the court for further information.

### **No Driver's License in Possession (A.R.S. 28-3169A)**

The charge will be dismissed if proof is shown by your court date that your driver's license was valid on the date and time the complaint was issued. If you did not have a valid driver's license at the time the citation was issued but have since obtained a valid driver's license, mail or bring proof to the court by your court date and no monetary sanctions will be imposed.

### **Insurance Violation (A.R.S. 28-4135 A, B, or C)**

The sanction for no insurance is:

- A minimum fine of \$965.00 will be assessed;
- Your driver's license, vehicle registration, and vehicle license plates will be suspended by MVD for 3 months (*first offense*) 6 months (*second offense*) or 1 year (*third offense*).

**A.R.S. § 28-4135 B or C:** If valid proof is shown to the court on or before your appearance date that valid insurance was in effect on the date the citation was issued, the insurance violation will be dismissed.

**A.R.S. § 28-4135 A,B, or C:** If you provide the court on or before your appearance date with proof of pre-paid 6 month liability insurance and a record from MVD showing no insurance violations in 24 months or only one in 36 months, the sanction may be reduced.

## Fines/Sanction Schedule

**A plea of guilty/responsible must be received by the court before payment can be accepted.**
