MINIMUM ADVERTISED PRICING POLICY

AquaLiv products must be advertised at no less than the Minimum Advertised Price. This applies to any advertised prices written in an openly accessible medium, i.e. websites, brochures, ads, radio, television, etc.

If any dealer advertises a price below MAP, or makes inference anywhere on their website or via any other medium, including third-party references on the internet, *or even by reputation*, that prospects will be able to get a discounted price through them, their dealership will be terminated. Examples of violations include offering any type of sale or special for single or quantity purchases, displaying "we will not be undersold" type claims, or advertising the ability to call or request information about specials, via any medium.

Our premium, state-of-the-art products deserve proven salesmanship. Advertising AquaLiv products at reduced prices dishonors our investment in research and development and dishonors the time and resources our dealers invest into selling AquaLiv products. You agree it is in the best interest of all dealers to abide by this policy at all times.

TERMS OF SALE

Payment terms are **PREPAID** unless credit terms are approved. Payment terms are **NET 30** days upon credit approval. Additional terms of sale including terms of payment and allowable discounts for each purchase are agreed to below as well as those specified on the face of each invoice. Balances carried past the due date or over established credit line will cause new orders to be held out of production. The Dealer hereby agrees to pay all collection and legal fees if such action be necessary, as well as 1.5% per month/18% per annum interest on any past due invoices, as well as any Non-sufficient fund charges as allowed by law in the event of a returned check. Property and products sold in association with extending credit to the applicant remains under the ownership of creditor until **PAID IN FULL**.

RETURN POLICY AND WARRANTY

AquaLiv offers a 90-day Unconditional Money Back Guarantee to its retail customers and recommends dealers to adopt the same policy (although not required for dealer status approval). Removing the risk for the customer makes it easier to sell and our return rate averages just 3%. AquaLiv accepts returns from dealers only for product that is unopened and unused. If a dealer gets a return from their customer, we suggest selling the system as used, just as AquaLiv does.

Product issues covered under warranty, such as repair or replacement of defective items, are fully supported by AquaLiv and are not the responsibility of the dealer. Warranty coverage and exceptions vary by product. Dealers should forward warranty issues to AquaLiv by emailing support@aqualivstore.com.
