About the Juror: Francine D'Olimpio, Kobalt Gallery

Established in 2006, Kobalt Gallery materialized out of owner Francine D'Olimpio's passion for fine art, but only after a long career in the restaurant business. Well known in Boston as the owner of Francesca's Cafe in the South End (which got its start in Provincetown in 1991), D'Olimpio featured a different artist each month on the walls of the eatery. With a move back to Provincetown in 2004, the seed for Kobalt Gallery was planted. D'Olimpio combined her business experience with her educational background, a BFA from the Massachusetts College of Art and an MFA from Boston University, to create a venue for contemporary emerging and mid-career artists to display and sell their work. Kobalt enters its twelfth season this year.
