➤ Recital will be held at Blair School of Music in Nashville: Friday, June 10, 7:00 PM & Saturday, June 11, 7:00 PM

➤ **Recital this year is ‘The Story of Oz’**

➤ Recital will be approximately 2 hours in length. Creative Movement, Preprimary, Primary, and Tap A,B,C ages 3-7 students will perform only one of the two shows. Their dances will be in the first act. They will be brought to their parents at intermission. These young students may go home or watch the second half of the show. ALL other students must stay backstage to the end of each show for bows in order to participate.

➤ June 9th is dress rehearsal which is required for all students.

– includes 4 tickets to recital.

Recital Fee is \$50.00 for the following classes only (who will perform one show) - includes 2 tickets.

Show assignments for each class will be made by January

Pre Primary & tap 5-6

Primary & tap 6-7

➤ Costumes will be ordered over the 2014 holidays in order to receive them in time for our 2015 recital. In the event that you are unable to participate in our recital, recital fees will be refundable upon written notification before January 15, 2015. After January 15, 2015, recital fees are no longer refundable.

➤ Costume fees are due Feb 1, 2015 and are \$65.00 per class or level. Combo classes will only have one costume fee of \$80 since there are two dances. The recital fees cover the cost of our production, not the costumes.
