# 1) Tri-Met Line #70 Discussion

Sponsor: Marc

Purpose: discuss, educate

- Proposed changes to Line #70 basically straighten it out, make it more efficient, provide better service and safety to the Cleveland High School students on the route, and avoid train crossings. Incidents at 26<sup>th</sup> & Powell prompted the change.
- The change will not affect the co-op's ability to get a permit for the Farmer's Market or to close down part of 21<sup>st</sup> once or twice a year.
- Parking: Can't avoid this impact but will try to minimize it by using far-side stops.
- Concern about already-increasing traffic.
- Streetlights: Area is not very well lit. Will more streetlights be added? (That's in the City's purview. TriMet will bring it up with them. Flashing crosswalk light is another possibility.)
- Delivery trucks: They often use the NE block twice a week, produce daily. Loading dock area itself should not be impacted. Bus will stop on the other side of the intersection. Trucks already double-park when there isn't a clear path to the loading dock.
- Should we pursue getting a loading zone? (Considered long ago and decided not to do it since it would impact customer parking.)
- Current crosswalk is not great, especially in winter.
- Handicap parking: There's only one spot, and it's not great, so those who need it usually park on 21<sup>st</sup>. (Should we ask for a different handicapped parking spot?)
- Schedule a 3-month check-in? Come to future Board meetings? July meeting.
- Hoping to implement this beginning on May 28.
- Might also add another crosswalk on the south side of the intersection.
- Charlotte can be a liaison with TriMet. Can we add a coupon to the May 28 notice? No, but TriMet can help promote Farmer's Market, etc, since it's now on the bus line.
- Moving the bus stops a block north would alleviate the Farmer's Market congestion.
- Do we want to establish an ongoing communication/relationship with Cleveland HS? This would be part of Charlotte's role.
