BASIC SUBMITTAL REQUIREMENTS

- Completed Application
- Owner authorization letter if applicable
- Submittal fee (impact fees may apply)
- Site Plan (2 sets)
 - o Lot lines
 - o Existing structures
 - o Size and location of proposed structure dimensioned from lot lines and between structures
 - o Proposed utility location
- Construction Plan – Include the following as necessary based on the proposed work (3 sets)
 - o Floor Plan
 - o Foundation Plan
 - o Framing Plan
 - o Cross-section with structural framing details
 - o Energy Code Compliance
 - o Mechanical Plan
 - o Plumbing Plan
 - o Electrical Plan
- Structural Plan and calculations if applicable (2 sets)
- Soils Report (2 sets)
- Truss/Joist Calculations – include verification of the Engineer of Record review (2 sets)
If deferred, add a note on the construction plan index sheet (deferred submittal fee will apply)
- Subcontractor list – Required prior to intermediate inspections
- Contractors Business License
- Bond Exemption Certificate from the State Bond Compliance Officer (602) 716-6056
Required for contractors or homeowners with building projects over \$50,000.00 in value
- Provide one of the following regarding sewer service
 - o Sewer receipt issued by the appropriate jurisdiction

 - o For new septic systems, a copy of the Construction Authorization

 - o For existing septic systems, a copy of the septic verification
