#### **Parent's or Guardian's Permission and Waiver of Liability**

We hereby give our consent for the below named student to participate in the Georgia High School Fencing League. We hereby acknowledge and agree that participation in the Georgia High School Fencing League may expose the student to risks of property damage and bodily or personal injury, including injury that may be fatal. We understand that these risks may include, but are not limited to, sickness, broken bones, sprains, concussions, injury from athletic equipment and, heart attack. We further understand that the student may be exposed to other risks, which may not be foreseeable. We hereby assume any and all such risks.

We hereby agree to waive all liability of the Georgia High School Fencing League, its member clubs, officers, employees, volunteer(s), coaching staff, parent(s), sponsor(s) for any accident, injury, illness or other mishap that might befall the below named student while participating in any sponsored event including practice, tournaments or fund raising activity.

#### **Authorization for Emergency Care**

We hereby grant permission to the coach and/or faculty sponsor, to any medical or surgical consultant deemed advisable, and any hospital to render the below named student any medical and surgical treatment that they deem necessary while we are not in attendance. We understand all possible effort will be made to inform us in case of such treatment.
