FOOD VENDOR APPLICATION

- TOA BBQ is the exclusive producer for the Taste of Autumn BBQ Championships and has the right to set policies for all activities associated with the event.
- Vendor Application deadline is JUNE 1. All vending applications will be reviewed and initial invitations will be extended by JUNE 15. Other vending opportunities will be reviewed if invitations are not accepted by JULY 15.
- All food items sold by the vendor at the event must be prepared at the event.
- Vendors must have a South Dakota sales tax ID, a South Dakota Health Department temporary permit and a certificate of liability. All paperwork must be returned by Sept. 3.
- SD sales tax paperwork will be given to you at registration on Sept 15. SD Department of Health Temporary permit application can be found at <http://doh.sd.gov/documents/Food/tempfood.pdf>
- Vendors are not allowed to sell beverages (water, soda etc.) without approval.
- Minimum vending hours - Friday, 5:00pm to 10:00pm Saturday 10:00am to 4:00pm. Quiet time is strictly enforced after 10:00pm in the City Campground.
- This agreement and the temporary permits must be returned prior to the event or vending cannot be allowed.
- BBQ Vendors are not required to compete in the KCBS Competition. But if you wish to compete the fee will be reduced.

AS A CONDITION OF PARTICIPATION IN THE TASTE OF AUTUMN BBQ CHAMPIONSHIPS

There is no "Rain Delay" schedule for this event, and if required the event may be canceled in whole or in part by Taste of Autumn BBQ Championships without prior notice. I agree to follow all guidelines of the South Dakota Health Department for food service as included in the Guidelines, including setting up and use of hand-wash stations. **No Pets will be permitted in the Food Booths or Cooking Areas.** No Alcoholic beverages will be Sold or Distributed by anyone other than vendors appointed by Taste of Autumn BBQ Championships. No flammable items or hazardous materials. Weapons, controlled substances or similar materials will not be permitted on the premises. Vendors shall continually police their area for safe and sanitary conditions. At the conclusion of the event, each vendor shall be responsible for his/her own trash removal. They will remove their own trash from within the booth, and dump only in the dumpsters designated as an event dumpster and shall restore the area to an acceptable condition as when you arrived.

HOLD HARMLESS: In recognition that there may be some risk, injury or property damage in such an undertaking at the Taste of Autumn BBQ Championships, the undersigned team cook and team releases and hold harmless Taste of Autumn BBQ Championships, and all of its members/officers, for any and all liability for injury or damages to any team members, or which may result from his/her participation, or which may occur to third parties by the act(s) of the members, his/her employees or agents. No action will be asserted or maintained against Taste of Autumn BBQ Championships and any or all of its members/officers and or sponsors including but not limited to Taste of Autumn BBQ Championships as a result of any occurrence in any way with the Taste of Autumn BBQ Championships. Further the team members shall defend any action so asserted or maintained arising out of any action taken by the team members. Further, I hereby grant full permission to the Taste of Autumn BBQ Championships organizers and/or agents authorized by them and to each of the entities and individuals listed above, to use any photographs, videotapes, recordings, or any other record of the event for any legitimate purpose. In addition, I agree to abide by all the rules of Taste of Autumn BBQ Championships and the Kansas City Barbecue Society and hereby assume full legal liability and responsibility for the behavior of myself and any of my guests.
