THE POUGHKEEPSIE FARM PROJECT OPERATES A PRODUCE FARM FOR THE PURPOSE OF DEMONSTRATING, TEACHING, AND PROMOTING SUSTAINABLE PRODUCTION AND DISTRIBUTION METHODS, PRESERVING COMMUNITY FARMLAND, AND IMPROVING ACCESS TO LOCALLY-GROWN AND HEALTHY FOOD, WITH A SPECIAL FOCUS ON THOSE WITH LIMITED ACCESS. THIS PROGRAM PROVIDES VOCATIONAL TRAINING TO 5-7 YOUNG ADULTS EACH YEAR WHO ASPIRE TO FARM FOLLOWING THE PRINCIPLES OF SUSTAINABLE AGRICULTURE. THIS PROGRAM IS THE BASIS FOR THOUSANDS OF COMMUNITY MEMBERS, HUNDREDS OF LOCAL YOUTH AND DOZENS OF COLLEGE STUDENTS TO ACCESS FRESH FOOD, DIRECTLY EXPERIENCE FARMING, LEARNING ABOUT ITS CONNECTS TO THE ENVIRONMENT, AND LEARN AND PRACTICE FARMING SKILLS.
