1. The listing of objects in the auction program will name the Donor **unless the Donor wishes to remain anonymous by checking here**  or by delivering a written request to the Foundation.
2. The Donor will assign any assignable warranty with respect to the Donation to any purchaser of the Donation at the auction.
3. The Sarasota YMCA accepts the Donation with the intent of selling it for the benefit of the Sarasota YMCA, which is a tax-exempt organization as described in I501(c)(3) of the Internal Revenue Code (the "Code"). Contributions made to the Sarasota YMCA are deductible for federal income tax purposes under section 170 of the Code. Bequests, gifts and transfers in trust to the Foundation are deductible for federal estate tax and gift tax purposes under I12055, 2106 and 2522 of the Code. **The Sarasota YMCA's Federal Taxpayer Identification No. is 59-1618413.**
4. To be entitled to a deduction, Internal Revenue Service Form 8283 must be attached to the Donor's income tax return if the total value of all non-cash contributions exceeds \$500.
5. For any donated item or group of similar items valued at more than \$500, the Internal Revenue Service requires donors to substantiate each contribution with a qualified appraisal and to submit Form 8283 to the Sarasota YMCA for donation acknowledgment before filing such form with the IRS. By law, the Sarasota YMCA is not allowed to appraise your donation for tax purposes. We suggest that you contact a qualified appraiser to have the donation appraised.
6. If the donation described above has a value of \$250 or more, this agreement must be obtained before the filing date of the Donor's income tax return (or extensions thereof) and it must be retained by the Donor to substantiate an income tax deduction. The Foundation has not provided any goods or services to the Donor in return for this donation.
7. The Sarasota YMCA is required to report to the IRS the price at which it sells any donated item, if the sale occurs within two years after receipt of the donation and the Sarasota YMCA is required to sign Form 8283 at the time of the donation.
