**IMPACT STATEMENT**

**ISSUE:** Approval of FY2018 Facilities Plan – Phase I.

**PERSON MAKING/SUBMITTING REQUEST:** Thomas Kranz, Interim Superintendent

**REASON FOR CHANGE OR ACTION:** At the request of the School Board, the Administration undertook an update of the Facilities Plan issued in 2015. The FY2018 Facilities Plan reflects an updated plan based on projected enrollment for the period of 2017 thru 2027, as well as the physical condition of the District’s facilities.

**RECOMMENDED/REQUESTED CHANGE OR ACTION:** Approval of the FY2018 Facilities Plan specifically Phase I with total projected costs of \$224,816,178. It is specifically understood that this is a projected costs and that when funds are appropriated the actual budget and the actual expenditures may be different that the projected costs reflected on this statement.

Phase I consists of constructing five (5) new schools at: Greene Elementary, George Mason Elementary, and Woodville Elementary, Elkhardt Thompson Middle School and George Wythe High School.

Please note that we are not requiring approval of the plan outlined for Phases II, III and IV. The reason for not requesting approval is that the facilities needs of the School District and the physical condition of our facilities may change; which could result in a different prioritization of the projects listed or in the type of project that may need to be taken at a particular school.

**OUTCOME:** Approval to move forward when funding is approved with Phase I of the Facilities Plan presented to the School Board.

**IMPACT:** Construction of five (5) new schools (Greene Elementary, George Mason Elementary, Woodville Elementary, Elkhardt Thompson Middle School and George Wythe High School) and renovations at two (2) schools (Fairfield Elementary and Francis Elementary).

**DISTRICT GOAL/PRIORITY OR DEPARTMENT GOAL/PRIORITY THAT IS SUPPORTED:** First class educational facilities. Securing funding to meet the priorities identified on the Facilities Plan, in order to comply with the Memorandum of Understanding and Corrective Action Plan with VDOE.

**BOARD POLICY OR ADMINISTRATIVE DIRECTIVE:** N/A

**Note 6:** If the recommendation is a "complete renovation/replacement", an analysis should be performed in order to determine whether a renovation or replacement should be undertaken from a fiscal prudence standpoint.

**Note 7:** Phase I represents the period of FY2019-FY2023; Phase II represents the period of FY2024-FY2028; Phase III represents the period of FY2029-FY2033; and Phase IV represents the period of FY2034-FY2038.
