

Rules and Regulations: 2018 Video Game Tournament

1. NO PURCHASE NECESSARY TO ENTER
2. Participant must be a high school student.
3. Tournament consists of four (4) single-elimination mini tournaments and one (1) championship game – five (5) games total.
4. Tournament points are awarded to participants per win.
5. Participants with a DoverPhila account receive three (3) points awarded to their overall tournament score.
6. Participants who register before the event receive three (3) extra points.
7. Participants who participate in all tournament practices on Thursdays at Park Place Teen Center receive three (3) extra points (May 3rd, 10th, 17th, 24th)
8. All winners will be announced immediately following the event.
9. All winners must be present to claim prizes or an alternate winner will be decided.
10. How to enter:

 - b) Fill out the registration and waiver form prior to the start of the tournament
