

Townscape's Geraniumfest and Kids Day Event Waiver

Please note: Waiver must include each individual participating in any Geraniumfest and Kids Day events prior to being given registration bracelets and, where the individual is a minor, must be signed by the parent or legal guardian. Please complete the following form including each individual and submit at Registration or Registration Bracelet Pick-Up. ALL PARTICIPANTS IN Townscape's Geraniumfest and Kids Day AND RELATED EVENTS ARE REQUIRED TO ASSUME ALL RISK OF PARTICIPATION BY SIGNING THIS GENERAL RELEASE AGREEMENT. Thanks!

1. Release: I, the undersigned parent/guardian on behalf of my child, myself, and our personal representatives, assigns, heirs, and executors, hereby fully and forever release, waiver, discharge and covenant not to sue Townscape Lynnfield, and all municipal agencies whose property and/or personnel are used and all other sponsoring or co-sponsoring groups or individuals related to Townscape and Geraniumfest and Kids Day, their officers, directors, employees, and agents (collectively "Releasees") from all liability to me, my child and our personal representatives, assigns, heirs and executors, for all loss(es) or damage(s) and any and all claims or demands therefore, on account of injury to myself or my child including that which may result in the death of me or my child, whether caused by the active or passive negligence of all or any of the Releasees or otherwise, in connection with my or my child's participation in the Geraniumfest and Kids Day activities.

2. Guarantee of Good Physical Condition and Understanding of Assumed Risk: I represent and warrant that my child is in good physical condition and is able to safely participate in Townscape's Geraniumfest and Kids Day. I am fully aware of the risks and hazards inherent in participating in Townscape's Geraniumfest and Kids Day and in spite of these risks voluntarily grant permission for my child to participate in it. I, on behalf of myself and/or my child, assume all risks of loss(es), damage(s), or injury(ies) that may be sustained by myself or my child while participating in Townscape's Geraniumfest and Kids Day.

3. Photographic Consent: I consent to the use of my/my child's name and photograph in broadcasts, newspapers, brochures and other media without compensation. 4. I warrant that all statements made herein are true and correct and understand that Releasees have relied on them in allowing my and my child's to participation in Kids Day and Geraniumfest.
