- Turn left onto Perry Ave, go approx. 48 mi.

- Turn right at stop light - Western State Hospital
- Take immediate left, look for Building 26

- Approx. two mi. on left

- Turn left in middle turn lane, follow signs
- Left turn into entrance
- Park in left parking lot

- At next stop sign (RV's in front), turn right

- Park in small parking lot - we'll meet as a group before entering

Whether coming from the north or south I-5, use exit 119, The "Dupont-Steilacoom" exit. North: Left at the exit signal, cross over I-5 to the 2nd signal. Turn right onto the Dupont-Steilacoom Road. South: Right at the exit signal to the 1st signal. Turn right onto the Dupont-Steilacoom Road. Stay on the D-S Road around N. Ft. Lewis and into Steilacoom (the D-S Road becomes "Union" in Steilacoom). At the intersection of Union and Lafayette (2nd stop sign) you will see the dock facility directly ahead of you. There is no free parking in Steilacoom. Immediately to your left are pay lots for \$5.00. Please allow yourself enough time to find a space prior to the scheduled departure time of the passenger boat.
