We may use your game data to provide and improve the Service and the game associated. By using the Service, you agree to the collection and use of information in accordance with this policy. The Service requires access to your mobile device's camera in order to scan QR codes used to transfer data created in the Service from one device to another. Please be aware that you can opt-in and out of this at any time during the use of the Service.

Information Collection And Use

We collect several different types of information for various purposes to provide and improve our Service to you.

Types of Data Collected

While using our Service, we may ask you to provide us with certain personally identifiable information that can be used to contact or identify you ("Personal Data"). Personally identifiable information may include, but is not limited to:

Usage Data
