III. SPECIAL HANDLING GUIDELINES AND WARNINGS

Subject has a history of violent interactions with civilians and prior care takers. Approach the subject from the left to maximize distance from [REDACTED]. Sedatives administered through the right arm are ineffective. Patient has become "inseparable" from patient designated TRIAL, suffering severe mental stress and increasing the likelihood of violent outbursts.

IV. CASE INFORMATION AND EVALUATION

Subject admitted to the Sanitarium on [REDACTED] due to a history of violent offenses. Subject transferred to Smedley's on [REDACTED] due to overcrowding. On arrival, subject appeared to be suffering from decreased level of consciousness and physical degradation possibly due to malnutrition.

Properly tamed, the regenerative properties it demonstrates would be simply invaluable. This is a foe truly worthy of being conquered. By closely observing the development of the disease as it progresses through a new host I have identified several pivotal stages of its life cycle. The information gained from these procedures will be invaluable in disrupting the illness' later stages. I believe I experienced the first stage of the disease some three weeks ago.
