ADDENDUM TO ADOPTION CONTRACT SPAY/NEUTER AGREEMENT

This is a legally binding contract dated ______, 2017 between VT Dog Rescue, Inc. ("Rescue") and ______, heirs, assigns and successors ("Adopter") relating to the adoption of ______ ("Dog") described herein. Adopter hereby acknowledges receipt of Dog and agrees to the following terms and conditions:

Permanent ownership of Dog is contingent upon compliance with this Addendum. Adopter understands and agrees to the following terms and conditions:

1. At the time of adoption, Adopter acknowledges Dog has not been spayed or neutered.

2. Adopter agrees to have Dog altered **no later than May 30, 2018** by a licensed veterinarian. Adopter accepts full responsibility for all costs associated with the spaying/neutering of Dog.



3. Adoption fee of \$350.00 must be paid by Adopter to Rescue at the time of adoption as stated in Adoption Contract.

4. Upon presentation of proof of altering either by Veterinary receipt or Certificate of Spay/Neuter, within fourteen days of completion of the altering procedure, Rescue agrees to refund \$75.00 to Adopter. This is not intended to cover the cost of the procedure.

5. Adopter acknowledges that failure to comply with terms shall be considered a breach of this Agreement which is deemed actionable by Rescue. Breach shall mandate the immediate return of Dog to Rescue at Adopter's expense.

6. Adopter agrees to and accepts financial responsibility for all legal fees, court fees, transportation charges, quarantine expenses, boarding fees, medical expenses and other related breach of agreement fees.

7. Breach of agreement excludes Adopter from any refund of the adoption fee.

ADOPTER AGREES TO HOLD RESCUE, ITS FOUNDERS, DIRECTORS, OFFICERS, AGENTS, VOLUNTEERS, ESTATE, HEIRS AND ASSIGNS HARMLESS AND INDEMNIFY THEM FROM ALL LIABILITY, CLAIMS, JUDGMENTS OR EXPENSES OF ALL SORT OR ANY NATURE ARISING OUT OF OR IN CONNECTION WITH DOG.
