FOR THE YEAR ENDED 4-30-16, 47 PEOPLE ATTENDED THE GOLF TOURNAMENT AND THE EVENT RAISED RAISED \$8,415, ALL OF WHICH WILL BE DONATED IN THE NEXT FISCAL YEAR. THE \$8,000 THAT WAS DONATED THIS YEAR WAS RAISED BY THE GOLF TOURNAMENT IN THE PREVIOUS YEAR.

THE OBJECTIVE OF THE ORGANIZATION IS TO FOSTER THE PROFESSIONAL, BUSINESS AND LEADERSHIP GROWTH OF ITS MEMBERS THROUGH EDUCATION AND PROGRAMS. THE ANNUAL GOLF TOURNAMENT IS THE ACTIVITY THAT ALLOWS THE ORGANIZATION TO PROVIDE SUPPORT AND EDUCATION TO ITS MEMBERS, WHILE RAISING FUNDS TO SUPPORT CHARITABLE GIVING. EACH PARTICIPANT IN THE GOLF TOURNAMENT WAS ABLE TO CLAIM A DONATION OF \$46.18 FOR MILITARY MEMBERS AND \$33.18 FOR CIVILIAN MEMBERS.

THE FOUNDATION ALSO HELD AN EVENT AT A NATIONALS BASEBALL GAME IN SEPTEMBER WHICH HAD 25 PEOPLE ATTENDING, A MARCH DINNER MEETING WHICH HAD 12 PEOPLE PRESENT, AND THE ANNUAL FOUNDER'S DAY DINNER IN APRIL WHICH HAD 112 PEOPLE IN ATTENDANCE.

DUE TO THE PROXIMITY OF THE FOUNDER'S DAY DINNER AND GOLF TOURNAMENT TO THE END OF THE FOUNDATION'S FISCAL YEAR, EXPENSES AND INCOME FROM THE EVENTS ARE NOT ALWAYS RECOGNIZED IN THE SAME FISCAL YEAR IN WHICH THE EVENTS TAKE PLACE.
