

Beer and Pizza For a Year Terms and Conditions

Order from the Grosvenor Grocery & Bottle Shop via Deliveroo for your chance to win!

1. Information on how to enter forms part of the terms and conditions of entry for the promotion.
2. The promotion commences at 11:00am on 24 July 2017 and closes at 11:00pm on 30 September, 2017 (**Promotion Period**).
3. The prize is a 6 Pack of Two Brothers Beer to the value of \$22 and a Grosvenor Hotel Pizza of choice to the value of \$23 (**Prize**) each week for a year. The Prize will be able to be claimed via credit provided by Deliveroo to a winning Deliveroo customer account. The credit provided by Deliveroo can only be used to purchase the Prize from Grosvenor Hotel on the Deliveroo Platform and only from Monday to Wednesday night each week between 12pm & 10pm. In the event these conditions are breached, the winner will automatically forfeit the Prize.
4. Each entrant who is 18+ years of age and resident in Victoria (**Eligible Entrant**) who orders from Grosvenor Grocery & Bottleshop on Deliveroo is eligible to enter into the draw to win the Prize. The Promoter will be giving away one Prize only. Eligible Entrants may submit multiple entries during the promotion period and are eligible to win one Prize only during the Promotion Period. Acceptance of the Prize is deemed acceptance of these terms and conditions.
5. The promoter is Deliveroo Australia Pty Ltd (ABN 73 67 915 640) of Level 1, 3 Wellington Street, St Kilda, Victoria, 3183 (**Promoter**).
6. Eligible entrants exclude:
 - a. Employees, directors, management, licensees and contractors of the Promoter, its related companies and agencies associated with the Promotion;
 - b. the immediate family of the above listed persons; and
 - c. any suppliers to the Promoter.
7. The Promoter is not responsible for any technical malfunction of any communications network or any late, lost, incorrectly submitted, delayed, ineligible, incomplete, corrupted or misdirected entry whether due to error, transmission interruption or otherwise. The time of entry will be deemed to be the time the entry is received by the Promoter.
8. The draw will take place at 5:00pm on 3 October 2017 during the Promotion Period at Level 1, 3 Wellington Street, St Kilda, Victoria, 3183. The winners will be determined by an automated random draw of all eligible entries. The first eligible entry drawn daily will be the winner of the Prize. The result of the draw (and any redraw) is final and no correspondence will be entered into.
9. The winners will be contacted by phone call and/or email by 6:00pm in the following week after draw has taken place during the Promotion Period. The winners are responsible for monitoring and answering their Email account and phone number.

Any part of a Prize that cannot be taken as stated will be forfeited. If any act, omission, event or circumstance occurs which is beyond the reasonable control of the Promoter and which prevents the Promoter from complying with these terms and conditions of entry, the Promoter will not be liable for any failure to perform or delay in performing its obligations and the Promoter reserves the right (subject to any applicable law) to cancel, terminate or modify or suspend

this promotion.

The Promoter and its related bodies corporate and their respective officers, employees, contractors and agents (**Promotion Parties**) will not be liable for any losses, damages, expenses, costs or personal injuries arising out of this promotion, the promotion of this promotion or the use of any Prize, including but not limited to any breach of these terms and conditions, contract or tort (including negligence) and any other common law, equitable or statutory remedy (**Damages**) whatsoever, including but not limited to direct, indirect and consequential Damages, including Damages that cannot reasonably be considered to arise naturally and in the ordinary course of things, even if those Damages were in the contemplation of the Promotion Parties.
15. The exclusion of liability in clause 15 does not apply to limit or exclude liability:
 - a. for personal injury or death suffered or sustained in connection with the supply of goods or services which are supplied by the Promoter in the ordinary course of business. To remove doubt, third party goods or services, which other than in connection with this promotion, are in the normal course of business supplied by a third party unrelated to the Promotion Parties, are not supplied by the Promoter in the ordinary course of business; or
 - b. to the extent it is not permissible at law to limit or exclude liability in the manner contemplated in that clause (in which case that liability is limited to the maximum extent allowable by law).
16. The Promoter reserves the right to redraw in the event of a winner being unable to satisfy these promotion terms and conditions of entry or forfeiting or not claiming a Prize. The Promoter will use all reasonable efforts to contact each winner by phone or email by 6:00pm on the day of draw. However, if a winner remains uncontactable at 10:00am 7 days immediately after that winner was drawn, their Prize will be considered forfeited. For any Prize that remains unclaimed or forfeited (through ineligibility or otherwise) as at 10:00am on the day immediately following the date of the original draw, the Promoter will conduct an unclaimed Prize draw at 10:00am on that date at the same place as the original draw, subject to any written direction given under applicable law. The first, and subsequent (if required) valid entries randomly drawn will be notified by phone or email within 1 hour after the draw.
