**DEFENDANT STEVEN AVERY'S AMENDED SUPPLEMENT TO
PREVIOUSLY FILED MOTION FOR RECONSIDERATION**

Now Comes Defendant, Steven A. Avery, by and through his attorneys, Kathleen T. Zellner and Steven Richards, and hereby amends his supplement to his previously filed Motion for Reconsideration of this Court's order filed October 3, 2017. The instant amended supplement is based on the discovery of additional new evidence. In support of this amended supplement, Mr. Avery states as follows:

Introduction

On October 23, 2017, Mr. Avery filed a Motion for Reconsideration of this Court's order summarily dismissing his motion for post-conviction relief pursuant to Wis. Stats. § 974.06. The Motion for Reconsideration is based in part upon (1) new evidence meeting the legitimate tendency test established in *State v. Denny*, 120 Wis. 2d 614 (Ct. App. 1984) connecting Bobby Dassey ("Bobby") and Scott Tadych ("Mr. Tadych") to the crime; (2) new evidence demonstrating that Mr. Avery's trial and post-conviction attorneys were ineffective for failing to adequately investigate evidence of Bobby as a potential suspect and/or impeaching Bobby's trial testimony

that Teresa Halbach (“Ms. Halbach”) left the Avery property in contradiction to Bobby’s testimony. (Motion for Reconsideration at pp. 33-38, 43-48); (3) a new *Brady* witness who provides evidence that Ms. Halbach left the Avery Salvage Yard on October 31, 2005;¹ (4) a new *Brady* witness who establishes that Ms. Halbach’s day planner was in her vehicle at the time of her murder and in the possession of Ryan Hillegas (“Mr. Hillegas”) after her murder; and (5) the State’s knowing use of the false trial testimony of Bobby and Mr. Hillegas. (Motion for Reconsideration at pp. 40-43).

As undersigned counsel’s investigation remains ongoing, additional new evidence continues to develop demonstrating that Bobby and Mr. Tadych meet the legitimate tendency test established by *Denny*. In summary, this evidence consists of: (1) brand-new admissions from Barb Tadych (“Barb”) and Mr. Tadych that they were aware that Ms. Halbach left the Avery property prior to her murder; and (2) an affidavit from Barb’s stepson, Brad Dassey (“Brad”) that Barb tried to remove relevant and probative evidence from the Dassey computer before it was seized by police on April 21, 2006. In addition to all of the other evidence referenced in Mr. Avery’s original § 974.06 motion and his Motion for Reconsideration, this new evidence establishes a reasonable probability that a different result would be

reached at a new trial based upon the totality of the new evidence. The abundance of new evidence mandates that an evidentiary hearing be held by this Court on Mr. Avery's claims.

(1) A recently recorded conversation with Mr. Avery, Barb, and Mr. Tadych provides new evidence of Barb's lack of credibility on the topic of the Dassey computer.

After Mr. Avery's Motion for Reconsideration was filed on October 23, 2017, he made a prepaid collect call to Barb on October 24, 2017. Barb is Mr. Avery's sister, the mother of Bobby, the stepmother of Brad, and the current wife of Mr. Tadych. The call was recorded by the Waupun Correctional Center. **(A copy of the call and transcript of the recording is attached and incorporated herein to this supplement as Group Exhibit 1).**

During the recorded call, Mr. Avery and Barb discussed the new evidence cited in Mr. Avery's Motion for Reconsideration connecting Bobby and Mr. Tadych to Ms. Halbach's murder. With regard to the disturbing internet searches and pornographic images found on the computer used by Bobby, Barb stated as follows:

Steven Avery: Why is all that shit on the computer?

Barb Tadych: There was nothing on my fucking computer. All this – I didn't even have fucking internet back then.

Steven Avery: Yes you did.

Barb Tadych: No I didn't.

Steven Avery: What do you mean you didn't?

Barb Tadych: No I didn't have internet.

Steven Avery: You did.

Barb Tadych: No I didn't.

Steven Avery: At that time, you did. Before that you did.

Barb Tadych: No I didn't.

Steven Avery: You didn't – well, it's on the computer.

Barb Tadych: I did not have internet.
Steven Avery: Well...
Barb Tadych: Well nothing. I didn't.

(See, Exhibit 1 at pp. 3-4).

Barb's vehement denial that her computer had access to the internet at the time of Ms. Halbach's murder is probative because it is unequivocally false. As cited in Mr. Avery's Motion for Reconsideration, a forensic examination of Barb's computer by forensic computer expert Gary Hunt ("Mr. Hunt") shows that the computer was used to access violent images of young deceased females, rape, torture, incest, and pedophilia on the internet at times when only Bobby was home (see below). Barb's denial is especially telling given that she took steps to delete the disturbing images before police seized her computer on April 21, 2006 (see below). This is additional new evidence that supports Mr. Avery's claim that the recovered images on the Dassey computer meet the legitimate tendency test established by *Denny* by implicating Bobby in Ms. Halbach's murder.

(2) Barb and Mr. Tadych have recently made admissions that Ms. Halbach left the Avery property before her murder.

Even more important, however, are admissions from Barb and Mr. Tadych in the phone call that Ms. Halbach left the Avery property before her murder.² Specifically, regarding Bobby's statements that he observed Ms. Halbach leave, the following conversation occurred:

Steven Avery: Bobby's home.

² Mr. Tadych participated in the recorded call, and can be overheard threatening Mr. Avery on multiple occasions, including his threat: "I'll put you in the fucking ground." (E.g., see, Exhibit 1 at pp. 11-14).

Barb Tadych : He wasn't always home.
Steven Avery: Well, you – well, most of the time he was home.
Barb Tadych: No.
Scott Tadych: He doesn't know fucking shit.
Steven Avery: And he said he [*sic*] left. She left.
Scott Tadych: That's right.
Barb Tadych: Yeah. She left.
Steven Avery: Yeah.
Barb Tadych: Yeah.
Steven Avery: Well, he didn't testify for [*sic*] that.

(*See*, Exhibit 1 at pp. 5-6) (emphasis added).

Barb, in response to Mr. Avery saying that Bobby had said “she left,” agreed, “Yeah. She left.” (*See*, Exhibit 1 at p. 6). Mr. Tadych, in response to Mr. Avery saying that Bobby had said “she left,” agreed, “That's right.” (*See*, Exhibit 1 at p. 6). Mr. Tadych's response indicates either that Bobby had told him that he (Bobby) observed Ms. Halbach leave the property, or Mr. Tadych's response indicates that he (Mr. Tadych) observed and/or had contact with Ms. Halbach *after* she left the property. (*See*, Exhibit 1 at p. 12).

Barb and Mr. Tadych's admissions are crucial to Mr. Avery's defense because the most important eyewitness for the State was Bobby, who testified that Ms. Halbach was still on the Avery property and that he saw Ms. Halbach approaching Mr. Avery's trailer before he left. (Motion for Reconsideration at pp. 33-35). Bobby made statements to his brother, Bryan Dassey (“Bryan”), that impeach Bobby's trial testimony and establish that, in fact, he had observed Ms. Halbach leave the Avery property before he left. (Motion for Reconsideration at pp. 35-36). Now, in addition

to the impeachment offered by Bryan, Barb and Mr. Tadych admitted that they knew that Ms. Halbach had left the Avery property before her murder.

(3) Barb's statements on Facebook on October 30, 2017, directly contradict Bobby's trial testimony.

At trial, Bobby testified that before he got in the shower, he observed Ms. Halbach walking over to Mr. Avery's trailer. (TT:2/14:38).

On October 30, 2017, Barb posted statements, using her Facebook account, that impeach Bobby's trial testimony about observing Ms. Halbach walking over to Mr. Avery's trailer. Specifically, Barb stated:

[...] just got off the phone with bobby [sic] and I asked him and he told me that:
He seen [sic] her pull in but that was it because he left to go hunting then. He said that is the truth.

Cindy Staufer Edajani (another Facebook user) replied:

“so he never see [sic] her walk towards steven [sic] home[?]”

Barb replied:

“No.” (See, **Barb's Comments on Facebook, attached and incorporated herein as Exhibit 5**).

(4) Mr. Avery has discovered new evidence that Barb attempted to remove evidence from her computer before it was seized by police on April 21, 2006.

Police believed that Barb's computer would contain evidence relevant to Ms. Halbach's murder. (See, **Affidavit for Search Warrant, attached and incorporated herein as Exhibit 2, ¶¶ 7-9**). Mr. Avery has discovered new

evidence that Barb hired a person to make deletions of incriminating evidence prior to the computer being seized by the police on April 21, 2005.

Mr. Avery has attached to this amended supplement the affidavit of Brad A. Dassey. (**Affidavit of Brad A. Dassey, attached and incorporated herein as Exhibit 3**). Brad is the half-brother of Bryan, Bobby, Blaine, and Brendan and Barb's stepson. (*See*, Exhibit 3 at ¶ 2). Brad avers that he had a conversation with Barb during a trip to visit Brendan at the Sheboygan County Jail. Barb stated that she had hired someone to "re-format" her home computer, and she wanted to know if "re-formatting" would remove what was on the computer. (*See*, Exhibit 3 at ¶ 3). Barb stated that she had the "re-formatting" done **shortly before** the authorities seized her computer. (*See*, Exhibit 3 at ¶ 4). During her conversation with Brad, Barb admitted that she did not want anyone to see what was on her computer. (*See*, Exhibit 3 at ¶¶ 4-5).

Brad further states that he contacted the authorities after this conversation because he thought that Barb was trying to remove evidence relevant to Ms. Halbach's murder. (*See*, Exhibit 3 at ¶ 6). The authorities interviewed Brad after he reported this information, but he was not called as a witness, by either side, to testify at Mr. Avery's or Brendan's trials. (*See*, Exhibit 3 at ¶¶ 8-9).

The new forensic examination of Barb's computer corroborates the affidavit of Brad. Mr. Hunt, who used 2017 technology to examine the computer, detected eight periods in 2005, close to the date of the murder, for which files are missing and "presumably deleted from the Dassey computer:" August 23–26; August 28–

September 11; September 14–15; September 24–October 22; October 23–24; October 26–November 2; November 4–13; and November 15–December 3. (*See, Supplemental Affidavit of Gary Hunt, ¶ 3, attached and incorporated herein as Exhibit 4*).

The foregoing is powerful evidence that Barb was aware that her computer had incriminating files on it that were relevant to Ms. Halbach's murder. Barb's efforts to delete the files before the computer was examined by authorities — in addition to her recent denials that she even had the ability to access the internet during the time in question — reinforces this conclusion.

(5) Further evidence impeaching Bobby's trial testimony.

Bobby testified at Mr. Avery's trial that after he arrived home on October 31, 2005, from working the 10:00 p.m. to 6:00 a.m. shift, he went to sleep until 2:30 p.m. (TT:2/14:35-36). Bobby's testimony is demonstrably false. Mr. Hunt has determined that the Dassey computer was used to access the internet at 6:05 a.m., 6:28 a.m., 6:31 a.m., 7:00 a.m., 9:33 a.m., 10:09 a.m., 1:08 p.m., and 1:51 p.m. (*See, Exhibit 4 at ¶ 4*). Bobby was the only person home during those hours because his mother, Barb, was at work, (Group Exhibit 6, STATE 805), Blaine and Brendan were in school, (Group Exhibit 6, STATE 360), and Bryan lived with his girlfriend. (Motion for Reconsideration, Exhibit G at ¶ 3).

(6) The State's theory that Mr. Avery initiated the appointment with Ms. Halbach on October 31, 2005, is refuted by Bryan's affidavit and the corroborating statements of his brothers, Blaine and Brendan.

Bryan's statement in his affidavit (Motion for Reconsideration, Exhibit G at ¶ 5) about Barb setting up the October 31, 2005 appointment with Ms. Halbach is corroborated by his brother, Blaine Dassey ("Blaine"), who told the authorities in an interview on November 7, 2005, "[. . .] it was Barb who made the arrangements to have the photo of the car taken." (**Police reports reflecting interviews of Brendan, Blaine, and Barb, attached and incorporated herein as Group Exhibit 6, STATE 0365**). Bryan's statement is also corroborated by his brother, Brendan Dassey ("Brendan"), who told the authorities in an interview on November 10, 2005, that he knew about "[. . .] the Auto Trader photographer because a few days before this, his mom told him she was coming to take photos of the van." (Group Exhibit 6, STATE 0348).

(7) In addition to the other evidence cited in Mr. Avery's prior motions, the evidence presented in this amended supplement requires an evidentiary hearing.

In order to set aside a conviction based on newly-discovered evidence, the defendant must establish by clear and convincing evidence that (1) the evidence was discovered after conviction, (2) the defendant was not negligent in seeking the evidence, (3) the evidence is material to an issue in the case, and (4) the evidence is not merely cumulative. *State v. Edmunds*, 2008 WI App 33, ¶ 13, 308 Wis. 2d 374, 746 N.W.2d 590. Once these criteria are established, the court looks to "whether a reasonable probability exists that a different result would be reached in a trial." *Id.* (quoting *State v. Armstrong*, 2005 WI 119, ¶ 161, 283 Wis. 2d 639, 700 N.W.2d 98).

The evidence referenced above meets the four threshold criteria. Obviously, Barb's and Mr. Tadych's admissions were not made until October 24, 2017. The evidence was therefore discovered after Mr. Avery's conviction and Mr. Avery was not negligent in seeking it. The evidence is material because it directly contradicts a key element of the State's case, *i.e.*, that Ms. Halbach never left the Avery property and was in fact walking towards Mr. Avery's trailer when she was last seen. Moreover, evidence that Bobby was untruthful about what he observed itself supports the conclusion that he meets the *Denny* standard. The evidence is not cumulative, as no other evidence directly refuting Bobby's trial testimony was elicited at trial.

Barb's efforts to conceal from police the potentially incriminating evidence regarding Ms. Halbach's murder on her computer also meet the four relevant criteria. The forensic examination of Barb's computer performed by law enforcement in 2006 with the available technology did not permit law enforcement to detect Barb's efforts to delete computer records of eight periods in 2005. The missing records, which were presumably deleted, were only discovered using 2017 forensic technology. Moreover, Mr. Avery cannot be faulted for failing to detect Barb's efforts at concealment prior to his trial; in fact, as recently as October 24, 2017, Barb denied that she even had internet during this period of time. The evidence is material because it supports Mr. Avery's theory of an alternative perpetrator. Nor is this evidence cumulative, as there was no evidence elicited at trial concerning Barb's efforts to remove evidence relevant to the Halbach murder on her home computer.

In summary, Bobby viewed violent images of young deceased females, rape, torture, incest, and pedophilia online, and he testified falsely about observing Ms. Halbach and her vehicle still being present on the Avery property before he left, in addition to other multiple inconsistencies in his statements to police.

Bobby and Mr. Tadych placed themselves in the same location as Ms. Halbach when she received her last phone call. (*See*, Motion for Reconsideration, Exhibit J; pp. 43-44). Mr. Tadych's multiple inconsistent statements severely undermine his credibility at trial. (*See*, Motion for Reconsideration at pp. 44-46). His recent telephone call with Mr. Avery demonstrates his knowledge that Ms. Halbach had left the Avery property on October 31, 2005. The October 24, 2017 telephone call also demonstrates that Mr. Tadych has violent, homicidal propensities manifested by his uncontrollable temper. Mr. Tadych threatens to physically assault Mr. Avery and, even more disturbingly, put Mr. Avery "in the fucking ground." (Exhibit 1 at p. 14).

It is an undisputed fact that some of Ms. Halbach's bones were found in the Dassey burn barrel. (TT:2/28:171; 229-32). No credible explanation has ever been provided by the State as to why Ms. Halbach's bones would be in the Dassey burn barrel if Mr. Avery had burned her whole body in his burn pit. Clearly, the jury understood that the State's argument was fatally flawed because it acquitted Mr. Avery of the mutilation charge, which was based upon burning the body in his burn pit.

Finally, there is a reasonable probability that had the evidence cited herein — in addition to the evidence relied on in Mr. Avery's § 974.06 motion and his Motion

for Reconsideration — been presented to the jury, a different result would be reached at trial, and the jury would have found reasonable doubt of Mr. Avery's guilt.

Conclusion



Hello. This is a prepaid collect call from (“uh, Steven Avery”). An inmate at Waupun Correctional Institution. All calls, other than properly placed attorney calls, may be monitored and recorded. To accept charges, press 1, to refuse charges—thank you for using Century Link. You may start the conversation now.]

STEVEN AVERY: Yeah?

BARB TADYCH: Yeah?

STEVEN AVERY: Yeah, what are you doing?

BARB TADYCH: What the fuck is going on?

STEVEN AVERY: What’s going on?

BARB TADYCH: Yeah.

STEVEN AVERY: Where?

BARB TADYCH: What do you mean, where? Why is she—why is she starting up with Scott and Bobby again?

STEVEN AVERY: Well, it’s going wherever the—the evidence is going.

BARB TADYCH: Yeah, so she’s gonna take down my fucking family again?

STEVEN AVERY: If that’s where the lead is gonna go, I don’t know.

BARB TADYCH: It’d fucking better not, because you’ll have a dead sister.

STEVEN AVERY: Well...

BARB TADYCH: Yeah.

STEVEN AVERY: Mm...well, I don’t think it was—it’s kinda him. It’s the other one.



BARB TADYCH: Who's the other one?

STEVEN AVERY: Your husband.

BARB TADYCH: He didn't do it either, 'cause, Steven, Christ, I was fucking with him.

STEVEN AVERY: Well—

BARB TADYCH: Yeah.

STEVEN AVERY: You weren't with him all day.

BARB TADYCH: No I didn't have internet.

STEVEN AVERY: You did.

BARB TADYCH: No I didn't.

STEVEN AVERY: At that time, you did. Before that you did.

BARB TADYCH: No I didn't.

STEVEN AVERY: You didn't—well, it's on the computer.

BARB TADYCH: I did not have internet.

STEVEN AVERY: Well...

BARB TADYCH: Huh? What the fuck are you talking about? I've never had internet. You can ask any one of my boys. I didn't have internet back then.

STEVEN AVERY: Well we—

BARB TADYCH: I didn't have internet—I didn't have internet until this place, here.

STEVEN AVERY: Umm... Well, I don't know.

BARB TADYCH: I know.

STEVEN AVERY: I don't know. All I know is it's on the computer. That's all I know.

BARB TADYCH: Well—

STEVEN AVERY: And the only time somebody was on was when Bobby was there alone.

BARB TADYCH: Really?

STEVEN AVERY: Yeah. Oh, there's times and everything.

BARB TADYCH: Huh?

STEVEN AVERY: There's times and everything. Bobby said he was sleeping, but he wasn't sleeping, he was on the internet. He was on the computer.

BARB TADYCH: He was doing shift, Bry—er, Steven.

STEVEN AVERY: He did. You—you're God dead right. This was during the day. After he got home from work.

BARB TADYCH: Bullshit.

STEVEN AVERY: Yeah. The time is there.

BARB TADYCH: Bullshit. Then somebody else was in my fucking house and was on it.

STEVEN AVERY: Bobby—

BARB TADYCH: How about that one? Huh?

STEVEN AVERY: Bobby's home.

BARB TADYCH: He wasn't always home.

STEVEN AVERY: Well, you—well, most of the time he was home.

BARB TADYCH: No.

SCOTT TADYCH: *[background]* He doesn't know fucking shit.

STEVEN AVERY: *And he said he left. She left.*

SCOTT TADYCH: *That's right.*

BARB TADYCH: *Yeah. She left.*

STEVEN AVERY: *Yeah.*

BARB TADYCH: *Yeah.*

STEVEN AVERY: *Well, he didn't testify for that.[emphasis added]*

BARB TADYCH: *[sighs]*



Barb stated that she had hired someone to "reformat" her home computer. She wanted to know if "reformatting" would remove what was on the computer.
4. Barb admitted her computer had some pornography stored on it and she claimed the computer had "viruses" on it. She had the reformatting done shortly before the



authorities seized her computer. Barb commented that she did not think the person she hired knew what he was doing.

5. She said she did not want anyone to get what was on her computer

Dassey was asked if Steven had a fire on Monday, October 31, 2005, and he said he did not see a fire on Monday. Dassey was asked if Steven had a fire on Tuesday, November 1, 2005, and he said that could have been the night he and Steven had a fire, but he thought it was on Wednesday, November 2, 2005. Dassey did go to school every day last week, and said if Steven had a fire during the day, he would not know about it.

Dassey was asked if he noticed any strange odor coming from the fire pit when he and Steven were burning, and he said no. He was asked if after the fire, Steven dug through the ashes or smashed any items that had not burned, and he said he did not see that. Dassey did say that Steven took some wire out of the fire and told Dassey to put it in a tan car over by the old garage near the shop. Dassey said the length of wire was long and he thought it was about 20'.

Dassey was asked how long he and Steven were outside burning at the fire on Wednesday night and he said probably 1½ to 2 hours. Dassey thought they both left the fire at the same time to go into their residences. He said that was the only fire he was aware of that Steven had last week.

)

Dassey was asked if he had ever gone back inside of Steven's garage since Monday night, October 31, 2005, when he helped push the gray Suzuki into Steven's garage, and he said no.

Dassey was asked to recall the events of Monday, October 31, 2005, when he and his brother Blaine got off the school bus and were walking towards their residence. He said as he and Blaine were walking up to their residence, which is right next door to Steven's residence, he observed Steven and Halbach talking outside Halbach's vehicle. He said as they got closer, he and Blaine commented to each other that must be the woman who was here from the Auto Trader magazine to take photos of their mom's van.

Dassey said as he and Blaine got closer to their residence, he observed Steven walk towards his residence and observed Halbach get into her vehicle. He did not see her drive away. Dassey knew about the Auto Trader photographer because a few days before this, his mom told him she was coming to take photos of the van.

Dassey said he and Blaine then walked into their house and their other brother, Bobby, was not home at the time. Dassey said Steven never came over to their residence the rest of that day, but Steven did call him on the telephone to ask him to help him push the gray Suzuki into his garage. Dassey was asked why his brother Blaine did not help him and Steven push the Suzuki, and he said right after Steven called him, Blaine called one of his friends, Jason Kresco, so he was on the phone with Kresco when he and Steven were pushing the Suzuki.

On Monday, November 7, 2005, at approximately 10:11 a.m., S/A Debra K. Strauss and S/A Lisa Wilson interviewed Blaine A. Dassey, DOB 12/03/1988. Dassey is currently in 11th grade at Mishicot High School. Dassey lives with his mother, Barbara Dassey (a/k/a Barbara Janda), 12930A Avery Road, Two Rivers, WI. This interview was conducted at the residence of Michael J. Kornely, DOB 10/27/1949, located at 104 Lilac Avenue, Francis Creek, WI, 920-684-7309. Dassey has been staying with Kornely since Friday, 11/04/2005. The purpose of this interview was to obtain information Dassey would have regarding his activities during the week of 10/31/2005.

For the purposes of this interview, the Averys and Dasseys will be referred to by their first names.

Blaine said on Monday, 10/31/2005, he got out of bed at 6:30 a.m. like he normally does. The bus picks him and his brother, Brendan Dassey (Brendan), up at the end of the gravel driveway sometime between 7:08 and 7:13 a.m. Blaine was asked if he was one of the first to be picked up by the bus driver or the last, and Blaine responded he was somewhere in the middle. Blaine was asked if he knew the name of his bus driver and he said he did not. Blaine described his bus driver as a young, nice female. Blaine thought he rode on Bus #3 but he was not sure. Blaine's school day starts at 8:00 and concludes at 3:05 p.m. Blaine described this day as a normal school day, with nothing out of the ordinary occurring. Blaine stated that, when school was over, he and Brendan rode the bus home and they were dropped off sometime between 3:30 and 4:00 p.m. Blaine said he and Brendan were dropped off at the same spot where they are picked up. Blaine was asked to describe where the bus drops him off and picks him up, and Blaine responded it was where the red/black Blazer is currently located.

Kornely stated that on some occasions, when Blaine arrived home from school, Blaine will call him. Blaine normally calls Kornely sometime between 3:40 and 3:50 p.m.

Blaine was asked if he recalled seeing anyone on the Avery property when he got off the bus on the afternoon of Monday, 10/31/2005. Blaine responded "not really." When asked what he meant by "not really," Blaine said he did not see anybody.

On 10/31/2005, the red/ black Blazer and the Monte Carlo were for sale at the end of the driveway. Blaine said he can recall those vehicles being there.

Blaine indicated when he got off the bus, he and Brendan walked directly to their house. Blaine said he did not talk to anyone except for Brendan, he did not see anyone, he does not recall seeing a vehicle that does not normally belong in the driveway, and he did not see Steve Avery (Steve).

When Blaine and Brendan walked into their house, Bobby Dassey (Bobby) was sleeping in his bedroom. Blaine explained that he and Brendan coming home woke Bobby up.

At approximately 5:00 that evening, Blaine received a telephone call from his friend, Jason Kresco.

message left her name and who she worked for. The caller also said she would be coming to Dassey's residence at approximately 1:00 or 2:00 on Monday (10/31/2005) to take the pictures. The caller left a call back number to reschedule if necessary. Blaine stated he thought this message would still be on their answering machine. Blaine said he thought the ad charge was \$85 and it was Barb who made the arrangements to have the photos of the car taken. Blaine said Barb has placed ads in this magazine in the past. The most recent advertised vehicle was Barb's black Lincoln. Blaine was asked if anyone else in the family used this magazine and Blaine said they did not.

Blaine was asked if he had seen any media coverage of the missing woman, including her name and the picture of her car. Blaine said he had, but these photos did not help Blaine recall having seen Halbach or her vehicle before.

Blaine had no additional information and the interview was at that time terminated.

During the interview, Blaine provided the Special Agents with a diagram of the trailers, garages, and burning barrels around the Dasseys and Steve Avery houses. This diagram will be electronically attached to this report and will be forwarded to DCIR.

On Monday, November 11, 2005, at approximately 2:15 p.m., S/A Strauss and S/A Wilson went back to re-interview Blaine to verify the activities of Wednesday, 11/02/2005 and Thursday, 11/03/2005.

Blaine said that one day last week (week of 10/31/05) Blaine was supposed to have a girl over to his house for a bonfire. This girl was identified as Adrianna Owens, a sophomore at Mishicot High School. Blaine said this bonfire never took place, as Owens later said she did not want to come out for a bonfire.

According to Blaine, on Tuesday, Wednesday and Thursday, Blaine did not leave his residence. Blaine said he did not go anywhere, he did not see anyone, and he could not recall Steve or Chuck coming over to his house.

Blaine also said he is sure that Chuck and Steve went to Menard's on Friday night instead of Thursday night. Blaine said he can recall going into his garage with Bobby looking for duct tape or tie downs for the dryer vents. While out there, Blaine saw Chuck in his flatbed smoking a cigarette and Steve run into his house as if to get something. Blaine estimated Steve was in his house for approximately 3 to 5 minutes. Blaine said he did not talk to Chuck or Steve at all. Blaine saw Steve come out of his house, get in the passenger seat of the flatbed, and they left the area.

The Special Agents asked Blaine why he had previously stated that before Chuck and Steve went to Menard's, they asked Blaine if he wanted to go along. However, Blaine had to decline because he had something else to do. Blaine said this was an error because he was confusing it with a separate

which was near the entry door. BARBARA JANDA sat at a chair with her back to the entryway door while S/A Holmes sat on JANDA's right side and S/A Kapitany sat on JANDA's left side.

For clarity purposes within this report, the JANDA and AVERY family members will be referred to by their first names throughout this report.

INITIAL STATEMENTS MADE BY BARBARA JANDA

Initially when the agents met with JANDA at the Y-Go-By Restaurant, S/A Holmes asked JANDA if she knew why the agents wanted to speak to her. JANDA told the agents that she believed the agents wanted to speak with her regarding the girl who was missing who took pictures "out there." JANDA told the agents she believed that the girl had been missing since Monday (10/31/2005), but that BARBARA was working on Monday. JANDA also told the agents that she believed that the girl was at "our house, I guess" on Monday when BARBARA was at work.

BARBARA told the agents that she believed her brother, STEVEN AVERY, was being framed for the missing woman's disappearance.

S/A Holmes told BARBARA that the agents appreciated her meeting with them. S/A Holmes also told BARBARA that law enforcement officers would be interviewing a lot of people regarding TERESA M. HALBACH'S (DOB: 03/22/1980) disappearance, and that the investigation was not focused on STEVEN AVERY. S/A Holmes told BARBARA that the investigation was focused on finding HALBACH first, and then learning what might have happened to HALBACH. BARBARA stated that she understood.

BARBARA JANDA'S WORK SCHEDULE

S/A Holmes asked JANDA to provide the agents with her work schedule beginning on Monday, 10/31/2005, and ending on Friday, 11/04/2005. JANDA stated that her normal work schedule was from 6:00 a.m. until 4:30 p.m. every day Monday through Thursday of every week. JANDA believed that she went to work at 5:30 a.m. on Monday, 10/31/2005. BARBARA stated that she always ended her work day at 4:30 p.m. and that she was usually always home at her residence by 5:00 p.m. at the latest.

BARBARA JANDA'S CHILDREN

S/A Holmes asked BARBARA if anyone lived with her at her residence on Avery Drive. BARBARA told the agents that all of her kids lived with her.
