The ANC 4C Commission, at a duly noticed public meeting, with a quorum of \_\_\_\_ present at its July 11, 2018, meeting, voted, with 8 Yeas, 0 Nays, and 0 Abstentions to authorize this *Letter of Support for Termination of Trump International Hotel Liquor License*.

The Commission also voted with 8 Yeas, 0 Nays, and 0 Abstentions to appoint the Commissioner for Single Member District 4C05, or any member of the Executive Committee in their absence, to be authorized to communicate this resolution and represent ANC 4C before the Alcoholic Beverage Regulation Administration (ABRA), related to this matter.

ANC 4C supports the view of local judges and religious leaders who have filed a complaint requesting that ABRA require the hotel's licensee, Trump Old Post Office LLC, to show cause as to why the Trump International Hotel's alcoholic beverage license should *not* be revoked. It is our considered view, that Donald Trump, the true and actual owner of the Trump International Hotel, is not a person of good character, doesn't meet the D.C. Code § 25-301(a)(1) requirements and therefore the license *should* be revoked.
