Hotel and Registration Information

Please make your hotel reservations by **August 13th** in order to receive the group rate.

The Village at Breckenridge has several options available to us and the rates are as follows:

- Classic Hotel Room \$135/night
- Studio Suite \$149/night
- One Bedroom Condo \$159/night
- Two Bedroom Condo \$199/night
- Three Bedroom Condo \$325/night

Room rates are subject to the taxable resort fee (\$10/day) and tax (currently 12.28%). The resort fee is per room, per night and includes parking, internet, use of the business center, local calls, newspaper, room water and other services and amenities that enhance your stay. Check in is at 4:00 pm and Check Out is at 11:00 am.

Please book your room at the Villages at Breckenridge ***by phone*** by calling the Breckenridge Hospitality Reservations Department at **(888) 525-1787** and ask for group code **BC2ME7** to reserve rooms for the **CMEA/CBE 2017**. When you make your reservation by phone, let the salesperson know you will be sending a check for full payment before August 22nd and to not charge your credit card.

You will need to give a credit card number to hold the room and will require a deposit equal to the first night of the reservation including the tax and resort fee. If you need to cancel you will receive all of your deposit less \$30, if you cancel within 21 days of the conference you will not receive any of your deposit. On August 13th, 2017, the hotel will charge your credit card for the total amount of your stay. In order to avoid this charge, you will need to send the hotel a check (with tax exempt form) for the full amount to be received by the hotel before August 22nd. In order to be tax exempt, you will need to pay with a school district check and include a tax exempt form. If you pay with a personal credit card or personal check, you will not be tax exempt.

CMEA and CBE registration includes:
