The Selectboard met at the Craftsbury Town Hall on Tuesday, April 14, 2015 at 7 PM. Selectboard present were Bruce Urie, Susan Houston and Jim Jones. Yvette Brown (Town Clerk), Michelle Warren (Clerk of Selectboard) and June Cook (Hardwick Gazette) were also present.

Minutes:

Bruce read his minutes from March 31, 2015. Jim Jones and Bruce Urie were at the Selectboard meeting. They approved March 10, 2015 minutes. They signed Weight permits from Walker Construction, Kelly Furn., Suburban Propane, Blow & Coty, Caulkins Sand & Gravel, HA Manosh & Vallencourt Trucking. Bruce and Jim approved \$500 to help compensate toward the error with the Antiques and Uniques hours. Bruce and Jim approved an alcohol license with C Village Store. They permitted a request from Mike Clark for the Craftsbury Soccer Camp August 3-7, 2015. Jim and Bruce approved LED street lights in the Village, Common and East Craftsbury, at no cost to the town, approximately 30 in all. **The Selectboard approved the March 31, 2015 Selectboard minutes as read.**

The Selectboard approved lodging for Yvette's mandatory Town Clerk's Voterlist Workshop in August.
