The Selectboard met at the Craftsbury Town Hall on Tuesday, May 19, 2015 at 7 PM. Selectboard present were Bruce Urie, Susan Houston and Jim Jones. Michelle Warren (Clerk of Selectboard) was also present.

## Minutes:

**Jim made a motion to approve the May 5, 2015 Selectboard minutes as printed, Susan seconded, motion approved.**

## Bridge Report:

The Selectboard discussed the State's annual bridge report. The Creek Road's bridge still has some serious conditions. One of the weight signs on the Creek Road's bridge was missing, it has since been replaced. Bruce mentioned that Vermont's Agency of Transportation will be starting a new program, inventorying all bridges that span 20 feet and under.

## Hatch Brook Road —Trash:

A vehicle was identified heaving bags of trash on Hatch Brook Road. The Selectboard will investigate further.

## Culvert Issue — Wendy Anderson:

Wendy Anderson sent a letter to the Selectboard requesting the Town clean out the culvert near her House. Bruce will talk to Steve about it.

## Committee/Commission Reports:

Jim said the Tree Walk is scheduled on the Common tonight. Susan suggested putting it on Front Porch, etc. to get more participation.

Susan mentioned that the Conservation Commission is meeting next week and the composting project is on that agenda.

Michelle is working on the new website draft still, plans to meet with the committee soon.

Road Foreman's Report:

Bruce said Steve and the crew are working on repairing the ice storm damage from last December, 90-95% is complete. Sicard is planning to work with the Town crew next week on sand.

Bruce said they planned to meet with Chris Brunelle regarding the Eden Mountain Road erosion project for the grant today, but Chris didn't show up.
