The Selectboard met at the Craftsbury Town Hall on Tuesday, September 6, 2016 at 7 PM. Selectboard present were Bruce Urie, Jim Jones and Susan Houston. Yvette Brown (Town Clerk), Steve Marckres (Road Foreman), Michelle Warren (Clerk of Selectboard), June Cook (Hardwick Gazette), Sierra Lowell, Eloise Girard and Melissa Jacobs were also present.

### Approve Minutes Last Meeting:

**Jim made a motion to approval the August 2, 2016 minutes as printed, seconded and approved.**

### Child Care Group Update:

The childcare group gave the Selectboard an update on their progress since the spring. They have separated into two groups, for short term and long term goals. They are looking into two possible locations for a childcare center. They have submitted one grant application already from Vermont Children's Trust, should hear the outcome in October. The group requested \$1,050 from the town to cover their childcare expenses and printing while they apply for the second grant from VCDP, which will require much more time. They mentioned the Selectboard may need to attend a fair housing training workshop in which the Selectboard agreed to. **Susan made a motion to grant \$1,050 to the childcare group (from the good neighbor fund), seconded and approved.**

### Property Entrance:

Dennis Goodwin had concerns with the entrance to his driveway and a missing boundary state after the bridge construction. Bruce will follow up with the state regarding the issue.

### A & U Final Figures:

The Selectboard is waiting to hear back from Ann-Marie Keppel for the final Antique & Unique figures.

### Peggy Sapphire & Robert Feinburg Unregistered Vehicles:

Jim and Bruce drove up and inspected the property adjoining the Sapphire/Feinburg property with unregistered vehicles and feel it is a state issue, not a town issue. Bruce will write a letter to Peggy and Robert.

Road Foreman's Report:

Quotes are all in for the Better Back Roads grant for the bank ledge on the intersection of Eden Road and Collinsville Road. The Town received two bids for trucking, ledge, excavator work, etc.— a \$12,860 bid from Peters and a \$16,000 bid from Denton. **Jim made a motion to accept Peters' \$12,860 bid, seconded and approved.**

Steve said gravel all set and sand is all up. They will be working on fixing the broken culvert on the Post Road.

Clerk's Report:

The Selectboard contributed, as requested, \$150 to Vt. Rural Development.

Yvette mentioned a parcel map grant, Bruce will look into it and talk to Wayne about it.

Other:

The Selectboard received a \$5,000 request from Lyndon State College to monitor and study noise from wind towers. Since it wasn't budgeted for the year, the Selectboard declined the request.
