# TERMS OF USE

Welcome to Chic Being. Chic Being is operated by "we," "us" or "our".

Please read these Terms of Use (the "Terms") carefully as they constitute legally binding terms and conditions and apply to your use of this Chic Being website and all other websites and applications owned or operated by Chic Being or its affiliates and partners where these Terms are posted (collectively, the "Services"). These Terms apply whether you are accessing the Services via a wireless or mobile device, a personal computer or any other technology, means or device. These terms do not cover other services, websites or any content, features and activities accessible or made available by any third party, unless specifically stated.

By accessing and using the Services, you acknowledge that you have read, understand and agree to be legally bound by these Terms and the terms and conditions of Chic Being's Privacy Policy, which are incorporated by reference. If you do not agree to these terms, then please do not access or use the Services.

# 1. ACCEPTANCE OF TERMS

Chic Being will process notices of alleged infringement, which it receives and will take appropriate actions as required by the applicable intellectual property laws. If you believe that your User Content was removed (or to which access was disabled) is not infringing, or that you have the authorization from the copyright owner, the copyright owner's agent, or pursuant to the law, to post and use the content in your User Content, you may send a counter-notice containing the following information to the Designated Agent:

If a counter-notice is received by the Designated Agent, Chic Being may send a copy of the counter-notice to the original complaining party informing that person that it may replace the removed content or cease disabling it in 10 business days. Unless the copyright owner files an action seeking a court order against the content provider, registrant or user, the removed content may be replaced, or access to it restored, in 10 to 14 business days or more after receipt of the counter-notice, at Chic Being' sole discretion.

irrevocably waive the right to trial by jury, and you agree, to the fullest extent permitted by law: (a) no claims by you shall be joined with any other and you agree not to participate in any claim brought by others; (b) YOU HAVE NO RIGHT OR AUTHORITY FOR ANY DISPUTE TO BE LITIGATED ON A CLASS-ACTION BASIS OR TO UTILIZE CLASS ACTION PROCEDURES; and (c) you have no right or authority for any dispute to be brought in a purported representative capacity on behalf of the general public or any other persons.

The Services are controlled within Poland and is directed to individuals residing in Poland. Those who choose to access the Services from locations outside of Poland do so on their own initiative, and are responsible for compliance with local laws if and to the extent local laws are applicable.
