**RE: BANKRUPTCY OF CAMP OF CHAMPIONS INC.
CLAIM AGAINST ESTATE AND POTENTIAL CHARGEBACK**

Please be advised, Camp of Champions Inc. (the "Company") filed an assignment into bankruptcy and Crowe MacKay & Company Ltd. was named its Trustee on June 9, 2017. Attached for your records is a copy of the Certificate of Appointment issued by the Office of the Superintendent of Bankruptcy. A 'Notice of Bankruptcy and First Meeting of Creditors' will be mailed to your address shortly.

We understand that you may have paid a deposit to the Company for summer camp. This letter is to confirm that the Company has ceased operations and accordingly will not be able to fulfill its obligations to you. The deposit you paid to the Company is considered an ordinary unsecured claim against the estate and it is unclear at this stage whether there will be any dividends to the ordinary unsecured creditors such as yourself.

If you paid your deposit by credit or debit card, we encourage that you consult with your financial institution and seek a chargeback. In the event that you are unable to recover your deposit and would like to file a claim against the estate, please do so by completing and returning the Proof of Claim (Form 31) which will be enclosed in the aforesaid 'Notice of Bankruptcy and First Meeting of Creditors'.
