PBC seeks to transform the lives of vulnerable young people through integrated experiential and adventure-based programming in schools and at our outdoor campus. PBC collaborates with schools, university partners and community-based agencies to develop SEL skills in youth.

Blairstown Campus Programs - Groups of students and their chaperones come from across the Mid-Atlantic region to stay at PBC's 264-acre Blairstown Campus in the northwest corner of New Jersey near the Delaware Water Gap for one to five days. These students come from public schools, independent schools, and community-based organizations. The majority of these organizations provide service to students from low income communities who face numerous challenges such as poverty, low-performing schools, high-crime neighborhoods, food insecurity, single adult households, court-involved youth, or youth in foster care. The Blairstown Campus serves as an extension of their school or community organization - a place where they can learn different skills they take back to their schools, families, and communities. These trips are organized by the administration or faculty of the visiting schools or organization expressly for the purpose of obtaining instruction in non-cognitive skills using PBC's social and emotional learning (SEL) curriculum. The SEL skills that PBC teaches can include verbal and non-verbal communication, leadership, cooperation, team-building, problem solving, healthy risk-taking, empathy and interpersonal skills; which skills are focused on depends on the needs of the individual student groups. During their time at PBC, students work in small groups with carefully trained instructors and spend the majority of the day in instructional activities, with time for meals, sleep and personal reflection/journal writing. Over 6,000 students and staff were served at the Blairstown Campus during 2015.

School and Community-Based Programs - PBC's School-Based Programs started in 2006 and are led by a licensed master's level social worker who engages students at high risk for dropping out; the large majority are low-income. PBC provides weekly leadership and SEL classes during the school year for small groups of students, plus case management for individual student situations, including referrals for other resources. Students also travel to our Blairstown Campus two-three times a year for intensive social emotional learning, leadership development, environmental awareness, and STEM applications. They also visit Princeton University through our Campus Expedition program. PBC's evidence-based approach focuses on engaging the whole child - socially, academically, and emotionally. The social worker engages in depth with students; interacts with parents/guardians; and monitors students' academics, attendance, discipline issues, and other progress. During the 2014-2015 school year PBC partnered with Global Neighborhood Secondary School in New York City and Rivera Middle School and Trenton Central High West Campus in Trenton, New Jersey to serve a total of 183 public school students.
