### REPORTS/ DISCUSSION/ ACTION

**Discussion:** Katie Chapman was appointed and sworn in as interim Board member for voting district 1. She will serve from July 1 - December 31, 2024.

**Discussion:** Superintendent Frank Schofield shared information regarding the possibility of working in partnership with Cache County School District, Box Elder School District and BTech to create a Center for Advanced Professional Studies (CAPS) program in our area. Within the program, students, during a semester in high school, are fully immersed in a professional culture, solving real-world problems, using industry standard tools, and are mentored by industry professionals.

**\*\*At 5:30pm, a motion was made to move into a Municipal Building Authority meeting.** Jeff Barben shared information on municipal bonds held by the district.

**\*\*At 5:45pm, a motion was made to return to the regular School Board meeting.**

**Action:** Secondary Schools Director, Liz Dickenson, shared information regarding the Student Mental Health Screeners that were administered to Logan High students. Information from these screeners was able to be shared with parents and resources were provided to help students in need. Moving forward, parents will opt in to participation following the screener being made available for parents to review. A motion was made to continue administering the screener to Logan High students and all were in favor.

**Action:** Business Administrator, Jeff Barben presented information regarding the request to refinance existing bonds when the time was right. Alex Buxton from Zions Finance also presented information regarding the savings the refinancing would provide. A parameter resolution was presented for approval. All were in favor.


**Action:** The Board approved the 2024-2025 School Board meeting schedule. It will be posted on the district website in coming weeks.

**Action:** The Board approved the 2024-2025 TSSA Plan. No changes to the plan were made from previous years.

**Action:** Policy EEG School Library Media Selection and Review was presented for approval. Adjustments were suggested based on State Board guidance and the policy will be brought back for approval at the August 13th meeting.
