Free or Reduced Cost / Subsidized Programs

The State of California *may* provide tuition assistance to households that meet specified income eligibility criteria. In order to be eligible for state subsidized education, a family's gross monthly income must be **below** the state's maximum monthly income ceiling. The maximum gross monthly household income ceiling varies by family size. Family size includes the child receiving services and the number of parent(s) or guardian(s) and any additional children who comprise the household in which the child receiving services is living.

Families with monthly gross income that exceed the below listed maximum amounts are not eligible for subsidized education.

Families with a monthly gross income below the listed maximum amounts *may* be eligible for free or reduced tuition fees.

2	\$5,889 per month
3	\$6,511 per month
