


Parent to Parent Newsletter

Ed Shemelya is currently the National Coordinator of the National Marijuana Initiative. This is an initiative within the Office of National Drug Control Policy (ONDCP) that is responsible for assisting and improving the capabilities of the 28 High Intensity Drug Trafficking (HIDTA) areas nationwide in carrying out the National Drug Control Strategy objectives of disrupting domestic trafficking and production of, and reducing demand for, marijuana and derivative products.



Monte Stiles served his entire professional legal career of 29 years as a state and federal prosecutor. For 24 years, Monte was an Assistant United States Attorney for the District of Idaho where he supervised the Organized Crime/Drug Enforcement Task Force – a group of agents and prosecutors who investigated and prosecuted high-level drug trafficking organizations, including Los Angeles street gangs, methamphetamine manufacturers, marijuana growers on public lands, and multi-state drug cartels.

Get informed through this community conversation, which will examine the state of marijuana in America, with the expressed purpose of separating the myths surrounding marijuana with the reality of today's marijuana. We will look at potency of marijuana, how it has changed, and the consequences resulting from it. Children over 12 are welcomed and encouraged at the evening presentation.

The Five Most Addictive Substances in the World



What are the most addictive drugs? This question seems simple, but the answer depends on whom you ask.

From the points of view of different researchers,

the potential for a drug to be addictive can be judged in terms of the harm it causes, the street value of the drug, the extent to which the drug activates the brain's dopamine system, how pleasurable people report the drug to be, the degree to which the drug causes withdrawal symptoms, and how easily a person trying the drug will become hooked.

Community Resource Spotlight: Stop Trafficking Together in Lake Country

Stop Trafficking Together in Lake Country (STTLC) Is an organization dedicated to abolishing human trafficking through prevention, collaboration, support, and advocacy.

STTLC prevents human trafficking through educating our community, which includes families, educators, law enforcers, corporate leaders, civic leaders, buyers and sellers. Our committee tends to raise public awareness through flyers, public meetings and social media.

STTLC will team up and pool resources with other local organizations to combat human trafficking. STTLC provides support through financial partnership, volunteerism, spiritual care, and survivor help. STTLC will push for just legislation and hold community leaders accountable.

Sex trafficking is the recruitment, harboring, transportation, provision, obtaining, patronizing, or soliciting of a person for the purposes of a commercial sex act, in which the commercial sex act is induced by force, fraud, or coercion, or in which the person induced to perform such an act has not attained 18 years of age.

Labor trafficking is the recruitment, harboring, transportation, provision, or obtaining of a person for labor or services, through the use of force, fraud, or coercion for the purposes of subjection to involuntary servitude, peonage, debt bondage, or slavery.
