# enrollment decisions

\*parents' choice, comfort levels, commitment

\*reopening priorities: health, safety, care, connection, love

\*shift from parent/ family support back to meeting needs of children in full day program

# arrivals and departures

### Arrivals and Departures

- Daily, 8-hour school opens July 1! (pending any new shelter in place orders)
- Separate, daily drop off and pick up windows each day between 8-5
- PS families: greetings at gate
- Todd families: greet in yards
- Fresh pens/ used pens
- No: late pick ups, 2nd drop offs
- 1 adult per household for pick ups and drop offs (aim)/ ALL ADULTS ONSITE WEAR MASKS (people over 12)
- Office is closed- all meetings and questions addressed virtually

### daily programming

### Daily Programming

- 8 hours of care per day with varied schedules per class
- Half days every Friday July-August for weekly staff meetings

#### **Small Classes:**

- 2 Toddlers classes
- o PSS
- o PSN 1
- o PSN 2
- Goal of all siblings being placed in the same class.

#### Work & Play

- All children will have opportunities for inside works and extended outside works/free play
- Timing of outside time on yard will be staggered by class
- Teachers will ensure that each child's individual learning needs are met in different spaces

#### Napping:

- Staff will position children's beds as far apart as possible (aim of 6 feet)
- Older children may not nap

# smaller classes and greetings

### Small classes and greetings

- Teachers will design small group classrooms of children (small classes) to suit best needs of classroom communities' peace and well-being of school as a whole
- NH staff will remain with their individual classes. In the case of teacher absence, Eve and Stacey and/ or one of our assistant teachers may fill in as needed

#### A bit more on GREETINGS:

- Parents are asked to stay out of "gate view" during pick up and drop off as children observe from the yard
- How to say goodbye? Be honest, direct, find routine- it's not always perfect- we don't expect it!
- Hugs and physical closeness within small groups AND teachers will wear masks

# cleaning and more...

### Cleaning and handwashing

- Handwashing
  - Presentations
  - Protocols (arrival, departure, bathrooms, mealtimes and more)
- Gloves
- Daily well checks/ temperature checks- children and staff (to be further described)
- Cleaning and disinfecting
- Additional cleaning and disinfecting (bathroom and materials- not shared between groups)
- CDC/ EPA approved processes and products
- CDC, Alameda County Public Health Department protocols followed

# health policies and well-checks

### **Daily Wellness**

- Wellness checks will occur every morning for staff & children (also noted in policy section)
- Only symptom-free children/ staff may attend school (cough, sore throat, runny nose, stomach ache, vomiting...)
- Staff reliant on parents to notify NH of any unusual observations/ behavior (sleep patterns, complaints, unusual eating patterns...)

### **Sick Policy**

- Children stay home for 72 hours post-fever/ without fever reducing medication
- Children stay home for 10-14 days post illness
- 14 days post positive covid test/ symptom free (CDC/ CA Health Department Guidance)
- If a child or staff member becomes sick at school, they will be isolated immediately and will not return to school for a period specified above

### **Sick Policy (continued)**

- If a child or staff member has COVID specific symptoms/ if a COVID case is confirmed or presumed, the following will occur:
  - If community member has exposed Nia House, we will contact Alameda County Public Health and follow protocol dictated by the Department
  - School closes if a case is confirmed or presumed within the school community (child, teacher, parent who has been at school)
  - Parents notified immediately via email of an anonymous confirmed or medically presumed case
  - Intense cleaning/disinfecting of the environment begins after 3 days of school closure
  - School reopens after Public Health Department guidance and direction on timing (depending on the case and contact tracing)
  - School will remain in session if community member has not directly exposed the Nia House community, but children/ staff/ parents in exposed family will self-quarantine for 14 days

### timelines

### **Timelines**

- Distance Learning ends on June 19th
- Contract signing/Finalized policy: by week of June 15
- Contracts will reference PARENT HANDBOOK with evolving policies as an addendum- direct email distribution, with evolving guidance
- Supply Fee will be collected by July 1, 2020
- School will resume July 1
- July 1-2 will be half days
- Tiered enrollment- July cohort will begin on July 1
- The second tier will begin September 1. The second tier will join/be distributed amongst the existing classes
- Children who are not fully enrolled in July will not receive distance learning support

### tuition

### **Tuition**

#### September starting children

- Full fee paying families are asked to contribute \$400 per month to hold space through August
- Families whose approved financial aid application qualifies them for:
  - tuition rates from 81-120% AMI (we'll remind you) are asked to contribute
    \$200 per month to hold space through August
  - Tuition rates from 0-80% AMI are not asked to financially contribute through August

### Potential future shelter in place plans

- NH plans to credit tuition to the following month of reopening, based on length of closure
- NH plans to offer childcare for essential workers who cannot work out of the home
